1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking exemption from Turnover, shall upload the supporting documents to prove his eligibility for exemption.
3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
4. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.
6. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.
7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

- (a) The firm will carry out repairs to the equipment/plant/vehicle in site located at Karu (Leh) (Locally) under its own arrangements.
- (b) The department will deliver the eqpt/plant/vehicle at workshop of the firm located at Karu/Leh (Place under its own arrangement).

12. The equipment/plant/machinery/ vehicle after repairs will be delivered by the repairer at the premises of the department located at Karu including its installation at Karu garrison (site at the cost and arrangement of repairer).

13. The rates accepted are for receipt of delivery of eqpt/plant/machinery/vehicle in accordance with conditions 2 & 3 mentioned above, loading into public carrier or repairers vehicle or unloading from public carriers/repairers vehicle at the consignees site shall be done by the repairer at his own cost.

14. All spares will be supplied by the firm and his rates would be deemed to include cost of all spares required to make the eqpt/plant/machinery/vehicle functional for the item of repair carried out.

15. All stores required for cleaning/servicing of the vehicle will be provided by the repairer at his own cost and his rates would be deemed to include the cost thereof.

16. All type of oil grease, where required will be provided by the repairer and his rates would be deemed to include the same.

17. The repairer will issue necessary petrol/diesel after the repair is completed for the purpose of testing and his rates would be deemed to include the same.

INSPECTION AND TESTING

18. The repair carried out will be inspected by the AGE E/M or his rep as detailed by him. The repairer will offer the eqpt/plant/machinery/vehicle to the inspecting authority who will carry out such inspections which are deemed necessary and the repairer shall provide all assistance as desired by the inspecting authority including gauges, measuring instruments etc as required.

19. After the eqpt/plant/machinery/vehicle is inspected jointly by the repairer and inspecting authority the equipment shall be subjected to such tests as mutually decided between the inspecting authority and the repairer to ascertain the function efficiency of the eqpt/plant/machinery/vehicle and any defects noted/pointed out by the inspecting authority shall be rectified by the repairer at his own (repairers) cost.

20. Any damage sustained to the equipment during repairs or testing shall be to the account of repairer and he would not be entitled to any payment for the loss or damage suffered by the eqpt/plant/machinery/vehicle while on his charge on whatsoever account.

STATUS OF EQUIPMENT/PLANT/VEHICLE/MACHINERY/STORES

20. The vehicle will be properly handed over to the repairers firm and a receipt for the same be obtained in writing by the department irrespective of whether the eqpt /plant/machinery/vehicle is being repaired in situ or in the workshop of the repairer. The items handed over to the repairer shall remain the property of the department and the firm shall have no right on it. The firm shall be wholly and fully responsible for the safe custody, proper handing, storage and processing of the same till the movement of its handing over to the department. The department reserves the right to recover or take back possession of the eqpt/plant/machinery/vehicle from the premises of the firm which were handed over without any damage or loss. Any damage or loss caused to the items in the custody of the repairer shall be made good by the firm, the assessment of damage or loss made by the accepting officer shall be final and binding.

21. The firm shall only be a custodian of the items handed over to him for which ownership and all other rights on the item will rest with the department.

GENERAL CONDITIONS

24. If the repair to the eqpt/plant/machinery/vehicle by the stipulated date is expected to be delayed due to any cause beyond the control, you shall immediately on happening of the event causing delay in the repairs, give notice thereof in writing to the accepting officer under intimation to the consignee, who after consideration for circumstances causing delay in the repairs may grant reasonable extension of time for completing repairs/works. Decision of Garrison Engineer 860 EWS will be final and binding in this regard.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
