ELIGIBILITY FOR PARTICIPATION IN TENDER:

Subject Tender is floated on Single Tender OEM (ST-OEM) basis and approved by Compet ent Authority as per 'Works & Procurement Policy of NTPC'. Accordingly, only M/s.Dow C hemical International Pvt.Ltd is eligible to participate in the subject tender.

Any Other Bidder(s) shall not be considered and bids of such bidder(s) shall be summarily rejected during Technical Evaluation.

Authorized Dealer/Channel Partner of M/s.Dow Chemical International Pvt.Ltd can also p articipate in this tender. However, such dealer/channel partner shall have to submit a Bi d-Specific Authorization Certificate from the manufacturer along with their bid. GeM Cont ract shall be issued in the name of the vendor who submits offer in GeM. Authorization is sued by any bidder apart from M/s.Dow Chemical International Pvt.Ltd will not be considered valid. Only one dealer of manufacturer noted above shall participate in the tender.

CONSIDERATION OF DEALER / DISTRIBUTOR:

i. Offers received from the Manufacturer or their authorized dealer are acceptable for furthe r evaluation. However, the authorization letter from the Manufacturer should be tender spe cific and they have to stand guarantee for the quality of supplied material ordered on their authorized dealer. In case of award, authorized dealer has to supply material from same m anufacturer only, along with supporting documents.

ii. In a tender, either the Authorized Dealer on behalf of the Principal/Manufacturer or Princi pal/Manufacturer itself can bid but both cannot bid simultaneously for the same item/produ ct in the same tender. If an authorized dealer submits bid on behalf of the Principal/Manufacturer, the same dealer shall not submit a bid on behalf of another Principal/Manufacturer in the same tender for the same item/product.
