The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.

- 2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking exemption from Turnover, shall upload the supporting documents to prove his eligibility for exemption.
- 3. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 4. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is

validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

- 5. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 80% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.
- 6. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:
  - i. If number of technically qualified bidders are only 2 or 3.
  - ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
  - iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
  - iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
  - v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

If the buyer has mentioned MSE purchase preference in ATC then service provider is required to upload necessary documents for MSE purchase preference for verification by the buyer during evaluation.

1. Technical terms:

Scope of work:

- a) Supply of S-BAND Telemetry Transmitter Assembly by vendor to be in compliance as per Document sta ted below:
- i) Document No: DRDO/DRDL/NAG/TM-Tx/01 Rev: DT: Technical specification Document for TM-Tx for NAG.
- ii) DRDO/DRDL/NAG/TM-Tx/02 Rev: DT: QT/AT Document for TM-Tx for NAG b) Amendments if any in above document will be intimated at the time of placing the P.O and the same may be accommodated by the ven dor.
- c) The required input material /Raw material is under vendor scope. Vendor should carry out all the raw m aterial testing's as referred in sL.no (a) above.
- d) Inspection / test facility: No inspection / test facility will be provided by BDL. All the fixtures, Jigs, tools & Equipment necessary for Fabrication/Inspection/Testing/ is under vendor scope.
- e) Complete Test Reports to be submitted along with manufacturers COC for component and Self conformity certificate (COC / self conformity certificate of Transmitter assembly shall be provided along with the supplies).
- f) Quantities ordered shall be qualified (usable) and deliverable units.
- g) Warranty period: The items supplied must bear warranty for 12 months from the date of acceptance at BDL. Warranty certificate should accompany with supplies.
- 2. The components should be free from burrs, damages, etc.
- 3 Inspection agency:
- (a) Inspection agency is MSQAA and/or their nominated inspection agency.
- (b) All the supplies should accompany with all the relevant inspection/test reports of the items cleared by the inspection agency.
- (c) Final acceptance will be given after receipt of the items at BDL stores along with I-Note/Green Card of MSQAA or their nominated inspection agency
- 4. Vendor shall inform BDL and MSQAA at various stages as per QA matrix prior One Week to review/witnes s and give clearance for further processing.
- 5)(a) All documents /drawings supplied along with this tender are the property of DRDO and 100% IPR is h eld with DRDO. These documents/drawings shall not be used for any other purpose, not to be disclosed, co pied and revised in any form without the permission of RCI (DRDO).
- 6. Delivery Term: The items shall be delivered at BDL stores and free delivery to BDL (F.O.R. BDL, Kancha nbagh, Hyderabad).
- 7. Replacement for the rejected items shall be provided on Priority basis at free of cost.
- 8. Delivery Schedule:

The items are to be supplied in two lots as per schedule given below.

- 9. All the measuring instruments/ gauges shall have valid calibration certificate and shall be produced to inspection agency of BDL on demand.
- 10.(a) All the Items shall be marked by engraving/labeling/ providing tag to ensure identification of component/ heat cycle during and after fabrication.
- (b)Engraving shall be done at the location marked/shown as in the drawing. For other components, don't have engraving location, shall be tagged/labeled with their identification number.
- 11. Packing & Forwarding:
- (a) Items should be securely packed as per standard specification / guidelines/ Technical specification & Q uality assurance plan for severe road / rail / air / sea transport conditions and the packing charges borne b y the supplier.
- (b) Freight, Transit Insurance etc., is in supplier scope and at their cost.
- 12. Supplier shall not supply non-conforming product against specification.
- 13. In case of non-conformity product, supplier has to inform BDL for further disposition action (i.e.re-work, rejection etc.).
- 14. Supplier shall retain the product related records (Processes, Quality Records etc.,) up to 3years.
- 15. BDL, its customer and regulatory authorities having right of access to the applicable areas of all vendor facilities, at any level of supply chain, involved in our order and all applicable records.
- 16. Supplier shall ensure that the persons carrying out the manufacturing of items under this purchase ord er be aware of Product conformity requirements, Product safety and Importance of ethical behavior etc.,
- 17. Supplier shall notify to BDL in case of suspected/detected Counterfeit parts (if any) during any stage of manufacturing for its prevention of further use and quarantine of the same.
- 18. Free Issue Material (FIM): No FIM will be issued by BDL.
- 19. Pre Bid meeting to be conducted.
- 2.Terms & Conditions
- 1. Payment terms: 90% payment with 100 % taxes and duties will be made within 30 days after receipt an d acceptance of material at BDL on pro rata basis. Balance 10% payment against submission of 5% PBG with validity till warranty period plus 3 months claim period. BDL reserves its right to release GST only after suppliers invoice / debit note is reflected in GSTR-2B/2A within the specified time limit mentioned in GST L aw.
- 2. Security deposit: Security deposit shall be submitted by the successful bidders for 5% of the order value (by way of Online payment / Demand Draft / Bankers Cheque / bank guarantee from scheduled banks) with in one week from the date of purchase order and valid up to successful execution of the order till the last delivery date as per purchase order plus 3 months claim period. SD will be released after successful completion of the order and against submission of performance bank guarantee as applicable.
- 3. Non-Disclosure Agreement: Vendor has to enter in to a Non-Disclosure Agreement as per the format provided by BDL.
- 4. Liquidated damages: Time is the essence of the P.O and delivery should be strictly insisted upon according to the delivery schedule given in the PO. In the event the supplier fails to deliver the goods / service, within the stipulated delivery period, BDL reserves the right to recover from the supplier, LD and not by way of penalty an amount as detailed in terms and conditions. A sum of 0.5% of the price only of the stores (Including duties, taxes) which the supplier has failed to deliver as aforesaid for each week of delay or part the reof, subject to a maximum of 10%. In case of extension of delivery period, increase in taxes shall not be borne by BDL, if delay is attributable to vendor.
- 5. BDL reserves the right to process and finalize the tender among the technically acceptable offers by con ducting on-line e-reverse auction ( after opening the price bids) and bringing all vendors to equal level play ing field in respect of techno-commercial conditions or may finalize the tender without e-reverse auction , i f required by BDL. The process adopted for e-reverse auction is at the discretion of BDL. The details of auct

ioning will be given to the vendors in advance and familiarization will be arranged for the same, if required

- 6. The Prices indicated in the PO (After finalizing the bids and release of PO) are firm and fixed i.e., no subject alteration / variation on any account unless specified in the purchase order.
- 7. Purchase Preference (PP) Clause (Make in India): order 2017 is applicable details can be submitted with the bids.
- 8 "HSN Code: Vendor has to provide HSN code (six digit code) for the items".
- 9 GST Clause: "BDL reserves its right to release GST only after supplier's invoice/debit note is reflected in GSTR-2B/2A within the specified time limit mentioned in GST law".
- 10 All other general terms and conditions as per BDL limited tender terms and conditions.

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
