#### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

#### 2. Generic

- 1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- 2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
- 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

#### 3. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

- Inspection: Inspection will be done by Assistant Manager (E&M), AHQ, Wani N
  orth Area or his authorized representative Foreman Incharge (Electrical), BTS d
  uring progress of work / completion of work.
- 2. The tenderer is advised to see the quantum of work / site condition before sub mission of tender to avoid Further complications.
- 3. The party should provide all the materials of good quality. The party is advised to enclosed the copy of supplied material delivery challan along with the bill as per the BOQ.
- 4. **Completion Period:** -90 (Ninety) Days from the date of handing over of job / site.
- 5. The rates once awarded will remain firm for the entire period of contract / agr eement.
- 6. The total amount shall be quoted including GST in the GeM Portal.
- 7. The tenderer cannot transfer / sub let any part of work.
- 8. <u>Transportation:</u> Transportation of all materials shall be the responsibility of bidder.
- 9. **Payment of Bill:** -95 % payment will be made within 21 days after submissio n of bill and balance 5 % will be paid after satisfactory performance for 01 (On e) year from the date of completion of work.
- 10. **Guarantee:** The work shall be guaranteed for a period of one (01) year from the date of completion. In case of pre-mature failure of the job within the guarantee period the same will be repaired free of cost by the party within 15 days from the date of joint inspection.

- 14. WCL, in no case shall be liable to pay any compensation to the staff / workme

- n in case of any injury/death of the workmen / staff etc. during the execution of the work. The contractor is to meet all expenses in such cases as per law.
- 15. The contractor shall ensure all safety measures for his workmen engaged for the jo b as well as men, material and equipment's of WCL. The contractor shall provide saf ety equipment like safety belt, insulated tools etc. as required and all safety rules a nd regulation shall be observed by the contractor as applicable.
- 16. <u>Liquidated Damages Clause</u>: If the contractor fails to maintain the require d progress in terms of the agreed time &progress chart or to complete the work on or before the scheduled date or extended date of completion, he shall, without prejudice to any other right or remedy available under the law to the company on account of such breach, pay as compensation (Liquidated Damages) @ half percent (1/2 %) of the contract price per week of delay. The aggregate of such compensation / compensations shall not exceed 10% (Ten) percent of the total value as shown in the contract.
- 17. **Force Majeure clause**: If the execution of the work by the tenderer / bidder is delayed beyond the period stipulated in the contract / work order as a result of outbreak of hostilities, declaration of an embargo or blockade or fire, flood, a cts of nature or any other contingency beyond the tenderer / bidders control d ue to Act of God, then Western Coalfields Limited may allow such additional ti me by extending the delivery period, as it considers to be justified by the circu mstances of the case and its decision shall be final.
- 18. The management reserves the right to accept / reject any or all tenders, split the work amongst more than one tenderer without assigning any reason whats oever.
- 19. All the corrigendum and amendments issued on website or otherwise from thi s office regarding this NIT shall be responsibility of the tenderers to comply wit h.
- 20. **Extension of Completion period**: If the execution of work by the tenderer is delayed beyond the stipulated period due to delay in handing over the work s as mentioned. WCL may allow such additional time by extending the comple tion period.
- 21. If any tenderer declines to execute and carry out the work after acceptance of their tender, without prejudice, WCL, shall have right to terminate the work or der after forfeiting the EMD and taking any other action deemed fit without ass igning any reason whatsoever.
- 22. **Engineer-Incharge:** Staff Officer (E&M), Wani North Area or his authorized repres entative will be Engineer-Incharge for this work.
- 23. <u>Termination of Contract</u>: -The company shall, in addition to other remedial steps to be taken as provided in the conditions of contract be entitled to cance I the contract in full or in part, if the contractor: -

Makes default in proceeding with the works with due diligence and continues to do so even after a notice in writing from Engineer-In-charge, then on the expiry of the period as specified in the notice.

Or

Commits default/ breach in complying with any of the terms and conditions of the contract and does not remedy it or fails to take effective steps for the reme

- dy to the satisfaction of the Engineer-In-charge, then on the expiry of the perio d as may be specified by the Engineer-In-charge in a notice in writing.
- 24. In case of electrical jobs one electrical supervisor (valid license holder) should be deployed for executing the jobs at our site.
- 25. Measurement shall be entered in the MB for the work done upto the date of completion.

- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
