Brief scope for PM of Drives shall be as below,

- 1. Tightening of all power and control connections of drives.
- 2. Cleaning of heat sink and related cooling fan for Chassis drives.
- 3. Checking of hardware with test voltages and a dedicated test kit.
- 4. Power components impedance measurement.
- 5. Minor parameterization changes if required.
- 6. Drive safety earth checking.
- 7. Capturing the backup with related software and handing over to Maintenan ce team of RCF.
- 8. System explanation to RCF engineers.
- 9. No load and Load trials of the system.
- 10. Replacement or commissioning of new drive at site with identical settings. However spare new drive shall be provided by RCF.
- 11. Troubleshooting, Analyzing the alarms and events in the drive in the event of any disturbance.

Tenure of the contract:

The tenure of the contract shall be **ONE year**.

- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
