- 1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity ÷ Original quantity) × Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

- 1. **Acceptable Makes:** All makes are acceptable. Offer to be submitted as per technical Specification and PQ Criteria given in bid.
- 2. Pre-Qualifying Criteria

- I. The Bidder should be an OEM or the authorized distributor or dealer or channel partne r of an OEM. In case of bidding by bidders other than OEM, the bidder has to submit aut horization certificate/valid dealership certificate issued by OEM.
- II. The bidder should have supplied LED flood lights with rating above or equal of 500 wa tts to any company during last 7 years prior to issue of this tender.

The Following documents are to be submitted for meeting the above eligibility criteria:

The bidder should submit relevant purchase order copy and supply invoices copy or delivery challan o r completion certificate in support of the above.

Note:

-

- a. In case bidders (Other than OEM) i.e authorized by OEM such bidder may submit documents of O EM (by whom the bidder is authorized) for satisfying/qualifying the above pre-qualifying criteria.
- b. NSL reserves the right to verify the authenticity of documents from the OEMs/ Concerned Buyers/ Customers. In case any specific adverse report is received against a tenderer, as an information or upo n enquiry made by NSL, in respect of capabilities and performance of the tenderer, after receipt of tender but before the opening of the Price Bids, the quotation /tender submitted by such tenderer is liable to be rejected. If such report is received after opening of the price bids, then also the quotation/tender of that tenderer is liable to be rejected.
- c. NSL also reserves the right to seek any additional related documents / any other financial documents, etc, if required.

d. Regarding Clarification of Bids/ Shortfall Document: -

As per guidelines, No post-bid clarification at the initiative of the bidder shall be entertained by NSL. In case of any shortfall of documents, NSL shall seek the respective clarifications from the concerned bid ders. However, no new credentials shall be allowed to be submitted after the opening of bids.

The shortfall information / documents shall be sought only in case of historical documents which pre-existed at the time of the tender opening and which have not undergone change since then. So far as the submission of documents is concerned with regards to pre-qualification criteria, after submission of the tender, only related shortfall documents shall be asked for and considered.

3. Other Terms & Conditions:

- **a)** The offers shall be submitted through GeM Portal only. No other mode is acceptable.
- **b)** Bidder should submit the BOQ Compliance documents.
- c) Bidder should necessarily mention the quoted make of the quoted items in the Bid documents.
- **d)** As per GeM Provision, further extension of the offer submission due date is not allowed by the Ge M Portal. Kindly submit offer on or before the due date to avoid any technical issue.
 - i. **Packaging:** Shock proof packaging to avoid damages during transportation. The Supplier sha II be responsible for the stores being sufficiently and properly packed, so as to ensure their being f ree from loss or damage on arrival at the destination.
 - ii. Delivery Period: Within 8-10 weeks from the date of placement of order / As per PR.
 - iii. Guarantee / Warranty: Applicable as per Gem GTC (If applicable as per items / PR).
 - iv. GST: Confirmation of percentage of GST on item wise basis.

- v. **Certificate required:** As per technical specification.
- vi. **Payment terms:** 100% payment with applicable full taxes will be paid within 30 days of gen eration of GRN after receipt and acceptance of material at NSL Stores, Nagarnar.
- vii. **Penalty Clause:** If the Seller fails to deliver any or all of the Goods within the original deliver y period (s) specified in the contract, the Buyer will reserve the right to levy/deduct/recover the p enalty for the delay @ 0.5% of the basic order value of the un-delivered quantity for each week or part thereof but subject to maximum 5% (five percent) of the total order value.
