### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

### 2. Buyer Added Bid Specific ATC

- Experience of Service/Supply of parts for the machines & equipments used in printing will be considered.
- PRE Bid Meeting:- It is mandatory to attend the pre bid meeting as the work is of specific nature. Bidders who will not attend the Pre bid meeting will be rejected in Technical Bid
- Site Survey:-- Pre bid Meeting and site survey is mandatory. Firms not attending pre bid meeting and site survey will be technically disqualified. The firms are to depute authorized technical representative to attend pre bid meeting and site survey.
- The successful firm shall provide the required parts as per the attached sanction order. As the department is conducting a pre-bid survey, the firm shall be responsible for supplying and replacing any additional parts found necessary during inspection or checking of the machine
- EMD furnished for the bid earlier, if any, for the same purpose shall be considered.

### 3. Forms of EMD and PBG

### 4. Certificates

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
