2. Generic

Option Clause: Excess Settlement. 3. Generic

4. Purchase Preference (Centre)

Bid reserved for Make In India products: Procurement under this bid is reserved for purchase from Class 1 local suppliers as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document 50%. Once registered, the Contractor/ Service Provider may track status of bills submitted, passed and paid by POWERGRID's Corporate Centre and Regional Office under this Contract and other Contracts a warded on it by POWERGRID by following the method detailed herein below:

- Once registered, the Contractor/ Service Provider can log-in to POWE RGRID's Vendor Bill Tracking System with Vendor Log-In ID and Passw ord.
- b) Bill entry is to be done by the Contractor/ Service Provider on POWER GRID's ERP Portal prior to submission of bill. An automated e-mail with unique reference number will be sent to the Contractor/ Service Provid er, which needs to be printed and attached on top of the correspondin g physical bill to be submitted by the Contractor/Service Provider to PO WERGRID.
- c) On receipt of physical bill, concerned POWERGRID's official shall onlin e acknowledge the receipt of bill. This action will trigger an automated mail to the Contractor/ Service Provider intimating that the physical co py of the bill has been received and is under verification / processing.

In case an MSE Bidder (based on the documents submitted in the Bid) is LI Bidder and further has not claimed "MSE Purchase Preference" in GeM for the specific package, GeM considers the Bidde r as Non MSE Bidder and mandatorily gives option to send price match request to other eligible M SE bidders (falling within %15 of L-1 bidder). Based on the outcome of the price matching, LI Bidd er is displayed in the Portal for POWERGRID to take a decision on whom to award the package.
