1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Generic

Option Clause: Excess Settlement. The excess settlement has been enabled for the service, allowing service providers to include additional charges up to a specified percentage of the item-level total value, including addons, in their invoices. Service providers must declare the applicability of additional charges during invoice creation and submit mandatory supporting documents to avail this option. The total invoice amount, including additional charges, shall not exceed the agreed-upon excess settlement percentage for the order.

3. Purchase Preference (State)

Bid reserved for MSE from the State of Bid Inviting Authority: Procurement under this bid is reserved for purchase from Micro and Small Enterprises from the State of Bid Inviting Authority having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal. If the bidder wants to avail themselves of the reservation benefit, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible to participate in this bid. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility based on documentary evidence submitted, while evaluating the bid. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

4. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

5. Buyer Added Bid Specific ATC

- 1. Earnest Money Deposit (EMD)
- 1.1. EMD Amount is Rs 10000 for the bid .
- 1.2. Bidders who are registered under MSME categories related to EMD exem ption are exempted from sub mitting EMD. For the same, bidder has to furni sh the certificate issued by Ministry of Micro, Small & Mediu m Enterprises f or registration under MSME category.
- 1.3. Bidder has to submit the scan copy of the proof of EMD in their technical bid.
- 2. Performance Bank Guarantee: Performance Bank Guarantee (PBG) will be 3% of the order value.
- 3. Eligibility Criteria
- 3.1. Eligibility Criteria for the bidder
- 3.1.1. The Bidder must have average annual minimum turnover Rs 10.80 Lakh per annum in last 3 financia I years i.e.2021-22, 2022-23 and 20 23-24 certified by CA.
- 3.1.2. The bidder must provide email address and one phone number to regi ster complaint if any during the warranty period. The bidder must have service centre in Madhya Pradesh
- 3.1.3. The bidder must submit an undertaking that they have not been black listed/ debarred by any state government / central government / PSU in I ast two years as on last date of bid submission on 500 rupees stamp pap er with notary.
- 3.1.4. The Bidder must submit their valid TAN/PAN, GST Registration Certificate.
- 4. Criteria for OEM
- 4.1. Bidder should produce OEM or MAF certificate .
- 5. Warranty Comprehensive onsite warranty for cctv system 1 years or 9 / 11 more from the date of install ation.
- 6. Bank Guarantee .
- 6.1 The successful bidder shall furnish an irrevocable Bank Guarantee in favour of District project Coordina tor for the value of 3% of the order value for a period of warranty 1 years including 60 days after the warranty period of items.
- 6.2 The Bank Guarantee should be of a Nationalized Bank/ Scheduled Bank situated in Indi a. .
- 7. FOR destination Destination for supply will be hostels as mentioned in the bid .
- 8. Others
- 8.1 Penalty of Rs 500 per day will be imposed after the delay from supply date.
- 8.2 No advance or part payment will be entertained.
- 8.3 Final payment will be released after successful installation of all equipment and physic al verification by the verification committee. In case of material rejected bidder must take back at his own cost. .
- 8.4 Deduction of tax as per government guideline will be applicable in the final payment
- 8.5 Quantity can be changed at time of final order
- 8.6 ISO 9001: The bidder or the OEM of the offered products must have ISO 9001 Certificati on.
- 8.7 BIS registration (CRS for safety general requirements as per IS 13202(Part 1) :Latest
- 8.8 Availability of security testing report for CCTV /VSS issued by standardization testing a nd quality certification Laboratory or any other agency notify by Meity.
- . 8.9 Service center in Madhya Pradesh is mandatory.

8.10 It is mandatory to repair faulty equipment in 48 hours after complaint. After 48 hours of the register c omplaint on given mobile/EMAIL for the faulty equipment the penalty of Rs 100 p er week will be imposed.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
- 16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
