Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM.   - a) they directly or indirectly control, or are controlled by or are under common control of anothe r entity; or
  - b) they have the same legal representative/agent for purposes of their bids; or
  - c) they have relationship with each other, directly or through common third party(ies), that puts them in a position to have access to information about or influence on the bid of another Bid der: or
  - d) Bidder and/or any of its allied entity(ies), which directly or indirectly control(s) or is(are) control of led by or is(are) under common control of another entity, has(ve) participated as a consult ant in the preparation of the design or technical specifications of the contract that is the sub ject of the tender; or
  - e) Bidder participates in more than one bid in this bidding process.
