- 1. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020 . In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.
- 2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Scope of Supply

Scope of supply (Bid price to include all cost components) : Only supply of Goods

3. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

4. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- Bidder must provide make and model of offered product.
- 2. Vendor must mention applicable GST rate and HSN code.
- 3. Vendor has to submit Stamped & Signed Technical Specifications, Bid docume nts (confirming compliance with all terms, conditions and specifications/ drawin gs of the Bidding Documents), failing which their bid shall be rejected.
- 4. PDI will be carried out as per approved quality plan, drawings and technical data sheet, by NTPC RIO'S re presentative at manufacturers works. Further, post dispatch, inspection shall be carried out by indenting authority based on technical specification at MUNPL stores, after receipt of materials.
- 5. **Guarantee/ Warranty:** The Guarantee/ Warranty period is 18 months from d ate of supply/ 12 months from date of use. The Guarantee/ Warranty Terms and Conditions shall be applicable to the material supplied against the PO. No separ ate Guarantee/ Warranty Certificate is required to be submitted by the Supplier along with the material. The Guarantee/ Warranty terms and condition shall be binding on the supplier.
- 6. The vendor must submit the **Calibration Certificate/Test Certificates** along with the material supply.
- 7. The vendor must submit the **Material Composition Certificate** along with the material supply.
- 8. **Payment Terms:** 100% Payment shall be made within 30 days after receipt a

nd acceptance of material at site. One copy of Duly Signed and Stamped Origin als of all documents/certificates required as per Purchase Order must be given to NTPC-Meja-MUNPL Store at the time of delivery of material, to avoid delay in Payment Processing.

9. Eligibility for Participation:

- 1.Subject Tender is floated on Limited Tender (LT) basis and Vendors eligible to participate have been shor t-listed and approved by Competent Authority as per "Works and Procurement Policy of NTPC". Any other bidder(s) who is not shortlisted /approved by Competent Authority for this bid shall not be considered and Bids of such bidder(s) shall be summarily rejected during Technical Evaluation.
- 2."NTPC enlisted vendors for the Material Enlistment Group (04 MEG-04 Supply of Plastic Refractory) can only participate in this tender.
- 3.Other vendors shall not be considered for this tender, however if they are interested to participate, can d o so in future tenders first by enlisting themselves for the respective product category (MEG). They shall h ave to visit NTPC CPC website www.vendor.ntpc.co.in and submit online application against items/services (Material /Contract Enlistment Groups) of their choice. If they meet the criteria stipulated in the Qualifying Requirement, they shall be enlisted in line with the Terms and Conditions of enlistment.
- 4.All participating vendors shall submit their latest enlistment certificate issued to them with mention of A ATO & EC values for the item category (MEG) or submit any other proof of their enlistment in which AATO & EC along with MEG is mentioned. Else vendors may also attach the mail sent to them by the C&M /buyer department for participation in this specific tender.

10. Delivery Instructions:-

- The Purchaser reserves the right to require delivery of the entire m aterial either in a single lot or in a maximum of two (2) staggered lots, at its sole discretion, based on site requirements.
- The Purchaser shall provide written intimation of the delivery schedule not less than three (3) months prior to the scheduled delivery date of each lot, and the Supplier shall supply the material within three (3) months from the date of such intimation.
- The quantity to be supplied under each lot may vary, subject to the r equirements of the site, and the Supplier shall have no claim for comp ensation or adjustment on account of such variation.
- In the event of staggered delivery, the Supplier shall ensure that bot h lots are delivered and completed within a period not exceeding twen ty-four (24) months from the date of issuance of the Purchase Order.
- 11. **RISK PURCHASE**: In the event of Supplier's failure to supply the material of ac ceptable quality in scheduled delivery period, MUNPL reserves the right to proc ure the materials from any other source at the Supplier's risk and cost and the difference in cost shall be borne by the Supplier. Further, MUNPL shall retain the right of forfeiture of PBG and or any other action as deemed fit.
- 12. Vendor must provide latest Purchase Orders from NTPC/PSU/GOVT. /other in support of their quoted rates to proceed further.

- 13. Copy of GST, Pan Card, Cancelled Cheque and Bank EFT Mandate for SAP vend or code creation shall be furnished.
- 14. **COMMON IP ADDRESSES:** Bidders are advised that the GeM portal records a nd displays the IP addresses used by both Buyers and Bidders/Sellers during the bidding process. Bidders are therefore advised to ensure that bids are submitte d from secure and independent networks to maintain transparency and avoid re jection on account of common IP usage.

For Item-wise Bids:

In case multiple bids for the same item are submitted using a common IP addre ss, all such bids shall be summarily rejected and excluded from further evaluati on. However, submission of multiple bids from the same IP address shall be per missible if the bids pertain to different items.

For Package-wise Bids:

If multiple bids for the entire package are submitted using a common IP address, all such bids pertaining to that entire package shall be outrightly rejected and will not be considered for further evaluation.

Under no circumstances shall the IP address of the buyer and the seller be the same. Any such instance shall be treated as a violation and will lead to disqualification of the bid.

- 15. **Conflict of Interest:** A bidder shall not have conflict of interest with other bid ders. Such conflict of interest can lead to anti-competitive practices to the detri ment of Employer's interests. A bidder may be considered to have a conflict of interest with one or more parties in this bid ding process, if:
 - a. they directly or indirectly control, or are controlled by or are under common c ontrol of another entity; or
 - b. they have the same legal representative/agent for purposes of their bids; or
 - c. they have relationship with each other, directly or through common third part y(ies), that puts them in a position to have access to information about or influence on the bid of another Bidder; or
 - d. Bidder and/or any of its allied entity(ies), which directly or indirectly control(s) or is(are) controlled by or i s(are) under common control of another entity, has (ve) participate d as a consultant in the preparation of the design or technical s pecifications of the contract that is the subject of the tender; or
 - e. Bidder participates in more than one bid in this bidding process.
 - f. In cases of agents quoting on behalf of their principal manufacturers/service p roviders, one agent cannot represent two manufacturers/service providers or qu ote on their behalf in a particular tender enquiry. One manufacturer/service pro vider can also authorize only one agent. There can be only one bid from the foll owing:
 - i. The principal manufacturer/service provider directly or through one Indian ag ent on his behalf; and
 - ii. Indian/foreign agent on behalf of only one principal.

For the purposes of this clause the term 'control' shall have the following meaning:

"Control" shall include the right to appoint majority of the directors or to control the management or policy decisions exercisable by a person or persons acting i ndividually or in concert, directly or indirectly, including by virtue of their share holding or management rights or shareholders' agreements or voting agreements or in any other manner.

Note: If two or more CPSEs/State PSEs participate in a tender, they will not be d eemed to fallunder the 'Conflict of Interest' provisions solely because they are u nder common control of Government of India/State Government. This is a non-negotiable tender and any deviation on any condition(s) or technical specification shall not be considered at our end.

- 16. Participation in this tender shall be deemed to comply with all tender requirem ent s and no separate "Nil Deviation Certificate" is required to be submitted by the bidder.
- 17. The Bidder along with its associate/ collaborators/ sub-contractors/sub-vendors / consultants/ service providers shall strictly adhere to the Policy for Debarment from Business Dealings and Fraud Prevention Policyof EMPLOYER/ BUYER displa yed on websitehttp://www.ntpctender.ntpc.co.inand shall immediately apprise E mployer/ BUYER about any fraud or suspected fraud as soon as it comes to their notice. If in terms of above policy, it is established that the bidder/his represent atives have committed any fraud while competing f or this contract then the bid shall be rejected and suitable action as per above policy shall be taken.

- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.
