The Scope of Work and Additional Terms & Conditions (ATC) of the Contract are as under:

-

A: SCOPE OF WORK

_

1. THE QUALIFIED CONTRACTOR SHALL PROVIDE TWO 6+1-SEATER COMMERCIAL SUV VE HICLE AS MENTIONED ABOVE WITH AC (Make after 01st January 2018), BEARING A COM MERCIAL NUMBER, ON MONTHLY HIRING BASIS WITH DRIVER.

- 2. The vehicle should be immaculate & in good running condition, and will be used for the conveya nce of BHEL employees, in and around Ranchi and in the premises of 3x800 MW PVUNL Patratu Sit e, Ramgarh, Jharkhand.
- 3. It is imperative to note that, the contractor will be required to provide the vehicle, as indicated in Clause (1) above, on all days of the month including the days of any sort of strike called, since BHE L & PVUNL comes under the purview of Essential service.
- 4. Only registered taxi (Yellow number plate) in good running condition, should be deployed which shall have valid registration and a valid comprehensive Insurance cover.
- 5. VEHICLE WILL BE HIRED ON FIXED MONTHLY RENTAL BASIS AND REIMBURSEMENT OF FUEL WILL BE MADE SEPARATELY AT THE PREVAILING RATE OF DIESEL ON AN AVERAGE OF 10 (TEN) KM RUNNING PER LITER OF FUEL. Diesel cost will be reimbursed as per average diesel price for the calendar month. The total KM running shall be calculated as per the trip sheet s igned by the user.
- 6. THE VEHICLE ON MONTHLY HIRING BASIS WILL BE REQUIRED FOR CONTINUOUS 12 HO URS' DUTY PER DAY. ADDITIONAL CHARGES FOR DUTY BEYOND 12 HOURS PER DAY WILL BE PAID @ RS 60/- PER HOUR. The reporting time shall be strictly as per the specific requirem ent of the concerned Authority / EIC. ADDITIONAL CHARGES FOR OUT STATION NIGHT HALT DUTY WILL BE PAID @ RS. 150/- (ONE HUNDRED FIFTY) PER NIGHT HALT AND IT WILL BE PAID FOR OUT STATION ONLY (EXCEPT FOR RANCHI AND PATRATU).
- 7. The parking charges, toll tax, barrier tax, state border entry tax etc., during duty, will be paid ext ra by BHEL on actual against documentary proof along with the monthly bill.
- 8. The driver must be holding a professional valid driving license of commercial cars wit hadequate experience. He should be well conversant with the roads and streets of surrounding areas, and also should have an experience of driving on high ways. The driver shall be able to do minor repairs of vehicle and attend to break downs, for which required tool box must be provided with each vehicle.
- 9. The owner/driver of the vehicle should maintain correct records of running kms, in the log book p rovided by BHEL for recording relevant details and must have mobile / cellphone facilities, so that he can be contacted as and when necessary.
- 10. Every morning the odometer readings of the vehicles shall be verified by HR departm ent / vehicle in charge before the start of subsequent trips.
- 11. In case of any accident involving the vehicle of the contractor supplied to BHEL, all liabilities what soever, on account of any loss or damage, to any person or property incurred, the same shall born e by the contractor himself solely and BHEL shall not be held responsible for the same at any cost.
- 12. The Vehicle shall be properly maintained and serviced at regular intervals i.e. every month by th e contractor at this own cost.
- 13. The Vehicles will be required to move in and around Ranchi, 3x800 MW PVUNL Patratu Site, Ram garh, Jharkhand and other places of Bihar, Jharkhand & West Bengal as and when required. **Howev er, for movement beyond Jharkhand actual cost of road permit will be reimbursed on su bmission of documentary evidence.**

- 14. The Contractor shall maintain sufficient funds with the Driver to meet any emergency requireme nt of fuel, parking fees, toll tax, emergency repair/maintenance etc. The Fuel tank of vehicle must be half filled at any time of duty hours.
- 15. Mileage meter (KM indicator Meter) reading should be in proper working condition/sealed. If KM i ndicator of the vehicle is not working or found to be tampered at any point of time, BHEL reserves t he right to impose a penalty or terminate the contract without any notice.
- 16. BHEL shall allow reimbursement of 5 km distance traveled each way for reporting to d uty from garage and from place of release from duty to garage.
- 17. The bidder may be required to make his vehicle available at this office inspection by BHEL for the purpose of assessing its suitability vis-à-vis the special terms and conditions.
- 18. The bidder may be required to ensure that his vehicle tyres should not be more than 2 years old. It is to be replaced after every 2 years.
- 19. **Safety:** The following accessories /safety devices shall be compulsorily installed /provided in the vehicle deployed by the contractor:
 - Seat belts
 - First Aid Box with Band Aid, Pain Killer Tablet, Bandage, Mercuchrome, Dettol, Cotton, Neo sporin ointment etc.
 - · A small fire extinguisher (in working condition)
 - · Stepney tyre in the vehicle
 - · Necessary Tool kits
- 20. The vehicle will run locally in Patratu or to & fro from Ranchi as per the instructions of BHEL representatives. Accordingly, the bidder must arrange for the stay of driver an d parking of vehicles at Ranchi/Patratu location.
- 21. The bidder has to arrange gate pass for the driver & vehicle for entering into PVUNL plant area. Non-availability of gate pass for more than one-day period shall be treated as non availability of vehicle services.

B: Contract Period:

Duration of this contract will be for a period of 12 (Twelve) months from the date of its comm encement with a provision of short closing of the contract, as per the requirement of BHEL. Re ntal charges of vehicles hired shall be FIRM and valid during the above period.

 The vehicle services may be discontinued as per BHEL's requirement and also due to non-satisfactory services rendered by the successful bidder with one months' notice pe riod.

D: Taxes, Duties, Levies:

- a) Evaluation of Bid will be done inclusive of GST.
- b) Normally GST on renting of vehicle is discharged by BHEL on reverse charge basis, but if any regi stered party enters for the bid and wishes to claim GST on forward charge basis, then the party has to indicate the same in bid. Input credit of GST paid on renting of vehicle is not available to BHEL, hence Evaluation of bid will be done on total cost to BHEL including GST.
- c) All taxes excluding GST but including, Royalties, fees, license, deposits, commission, any State o r Central Levy and other charges whatsoever, if any, shall be borne by the Contractor and shall not be payable extra. Any increase of the taxes, excluding GST, GST Cess & BOCW Cess, at any stage during execution including extension of the contract shall have to be borne by the contractor. - f) In case of raising any Supplementary Tax Invoice (Debit / Credit Note) Bidder shall issue the sam e containing all the details as referred to in Section 34 read with Rule 53.
- g) Bidder shall note that in case GST credit is delayed/ denied to BHEL due to delayed / non-receipt of goods and /or tax invoice or expiry of the timeline prescribed in GST Law for availing such ITC, o r any other reasons not attributable to BHEL, GST amount shall be recoverable from the vendor alo ng with interest levied / leviable on BHEL, as the case may be.
- h) Bidder shall upload the Invoices raised on BHEL in GSTR-1 within the prescribed time as given in the GST Act. - b) Make in India (MII) Certificate or Declaration (As per GeM rules)
- c) Proof of Experience as per PQR
- d) Proof of Turnover as per PQR
- e) NIT / Bid Document signed in all pages as an acceptance to all the terms & conditions of the NIT
- f) RC of the probable vehicles to be deployed as per the specifications mentioned in the NIT
- g) Proof of Office in Jharkhand (If the agency or vehicle to be deployed is from any other state)
