as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity  $\div$  Original quantity)  $\times$  Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

# 1. PRICE BASIS:

The Contract Price shall be FIRM & FIXED during the entire execution of the Contract and shall n ot be subject to any variation except on account of Statutory Variation on direct transaction bet ween the Employer (DVC) & the Contractor.

#### 2. INSPECTION

Goods supplied will always be subject to our inspection on arrival at the destination. The supplier will be held responsible for the stores not being sufficiently and properly packed at his expenses fo r transport by to be quoted by the Bidder; so as to ensure them being free from loss or injury at th eir destination. In accepting the order, you are understood to accept to all responsibilities for any i nfringement in registered design, trademark, patent rights etc.

## 3. PRE-DISPATCH INSPECTION:

Pre-dispatch Inspection will be done at Vendors site (If applicable) Final Inspection Checking of all materials will be based on reference QAP (Quality Assurance Plan) which indicative only, agency h as to submit actual QAP for DVC's review and approval. Testing and inspection shall carry out as p er the approved QAP before supply of material/items/equipment. Vender should provide all relevant test certificates along with dispatches. Acceptance of material by DVC at DVC Site by DVC Executives shall not in any way relieve to the Vendor.

#### 4. TRANSIT INSURANCE

Arrangements for transit insurance can be made by DVC as per Mega Risk Policy arranged with exi sting underwriter as per time being imposed.

## **5. PAYMENT TERMS:**

100% payment will be released within ten (10) days of issue of consignee receipt-cumacceptance certificate (CRAC) and on-line submission of bills subject to submission and accepta nce of SDBG/ePBG.

## 7. GUARANTEE/WARRANTY

The Vendor shall warrant that all material supplied under the Order shall be new, unused and c onform to the Purchasers / owners requirements and specifications as mentioned in the NIT.

The Vendor shall guarantee the material under the Order for 18 months from the date of deliver y or 12 months from the date of commissioning whichever is earlier.

The date of delivery to be reckoned as the date of receipt of the material at site by the consign ee. The vendor shall agree to replace any material, which has been proved defective or fails to conform to the desired specifications free of cost to the purchaser within the Guarantee/Warranty period. The guarantee period for such replaced part shall be the same as that of materials specified earlier.

Inspection and acceptance of material by DVC at DVC Site shall not in any way relieve the vend or from the responsibility for proper performance during the guarantee period.

## 8. LIMITATIONS OF LIABILITY:

Except in cases of Criminal Negligence or wilful misconduct,

(i) The Contractor and The Employer shall not be liable to the Other Party for any indirect or con sequential loss or damage, loss of use, loss of production, or loss of profits or Interest costs, pro vided that this exclusion shall not apply to any obligation of the Contractor to pay liquidated da mages to the Employer

AND

(ii) The aggregate liability of the Contractor to the Employer, whether under the Contract, in tort or otherwise, shall not exceed the total Contract Price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment, or to any obligation of the Contractor to indemnify the Employer with respect to patent infringement, copy right, workman compensation.

#### 9. SECURITY DEPOSIT-CUM-PERFORMANCE GUARANTEE:

To ensure due performance of the contract, the Supplier/Contractor/ Service Provider receiving the LOA/PO/Work Order is required to furnish the required performance security **within Fourte en (14) days** from the date of issuance of Letter of Award (LOA)/ Work Order (WO)/Purchase O rder (PO).

Performance security should be for an amount equivalent to 3% of the Letter of Award (LOA)/ Work Order (WO)/Purchase Order value.

Submission of Performance Security is not necessary for a contract value up to Rupe es 1 (one) lakh.

Performance security may be furnished in the form of Insurance Surety Bonds, account payee d emand draft, fixed deposit receipt from a commercial bank, bank guarantee (including e-Bank Guarantee) issued/ confirmed from any of the commercial bank in India or online payment in an acceptable form, safeguarding DVC's interest in all respects.

## 11. LIQUIDED DAMAGES CLAUSE:

If the Seller/Service Provider fails to deliver any or all of the Goods/Services within the original/r

e-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, © 0.5% of the contract value of delayed quantity per week or part of the week of delayed period, until actual delivery or performance, as pre-estimated damages not exceeding 5% of the total contract value without any controversy/dispute of any sort whatsoever. However, in case of in ordinate delay maximum deduction shall be 10% of the total contract value.

The Employer (DVC) reserves the right to purchase the material / spares/ equipment /service & works from elsewhere at the sole risk and cost of the Contractor and recover all such extra cost incurred by the Employer in procuring the material, service and works. The procedure to be foll owed is given below:

- a) After the expiry of the specified date of delivery / completion period, if the Contractor fails to deliver the materials/ complete the work a notice will be given to the Contractor for delivering the material/ complete the work immediately.
- b) If the Contractor fails to deliver the material/complete the work, a final risk and cost notice will be served to the Contractor by registered post with A/D, clearly indicating that if he fails to deliver the materials/ complete the work within 7 days of the receipt of the letter, the same shall be outsourced from other sources at the risk and cost of the Contractor.
- c) The existing order has to be closed and action will be initiated by the Employer for procurem ent / completion of work & services of the balance items/ portion. While taking such action the defaulting Contractor may not be given an opportunity against fresh enquiry/limited tender
- d) If it is found that price has come on the higher side, then the difference between the original price and the new price will be recovered from the Contractor.
- e) For the purpose of recovery of the amount, unpaid amount / security deposit by the way of B G as provided by the Contractor will be adjusted first. If there is any balance left to be recove red, the Contractor should be informed to deposit the money at the earliest.
- f) If he fails to deposit the balance amount no further enquiry will be given as per banning procedure of DVC.
- g) In case the amount is considerable, legal action may be considered by the Employer.

Alternatively, the Employer (DVC) may short close the Order stating the reason for not resorting to risk purchase clause.

In the event of recourse to alternatives as mentioned above, the Employer (DVC) will have the r ight to re-purchase the stores or complete the work, to meet urgency in requirement caused by Contractor's failure to comply with the schedule of delivery or completion of the work or service s irrespective of the fact whether the materials / equipments/ work/ services are similar or not.

#### 13. Conflict of Interest:

A bidder shall not have conflict of interest with other bidders. Such conflict of interest can lead to anti-competitive practices to the detriment of Employer's interests. A bidder may be considered to have a conflict of interest with one or more parties in this bidding process, if:

- a) they directly or indirectly control, or are controlled by or are under common control of another e ntity; or
- b) they have the same legal representative/agent for purposes of their bids; or
- c) they have relationship with each other, directly or through common third party(ies), that puts them in a position to have access to information about or influence on the bid of another Bidder; or
- d) Bidder and/or any of its allied entity(ies), which directly or indirectly control(s) or is(are) controll ed by or is(are) under common control of another entity, has(ve) participated as a consultant in the preparation of the design or technical specifications of the contract that is the subject of the ten der; or
- e) Bidder participates in more than one bid in this bidding process.
- f) In cases of agents quoting on behalf of their principal manufacturers/service providers, one age nt cannot represent two manufacturers/service providers or quote on their behalf in a particular te nder enquiry. One manufacturer/service provider can also authorize only one agent. There can be only one bid from the following:
- i) The principal manufacturer/service provider directly or through one Indian agent on his behalf; a nd
- ii) Indian/foreign agent on behalf of only one principal.

For the purposes of this clause the term 'control' shall have the following meaning:

"Control" shall include the right to appoint majority of the directors or to control the management or policy decisions exercisable by a person or persons acting individually or in concert, directly or indirectly, including by virtue of their shareholding or management rights or shareholders' agreements or voting agreements or in any other manner.

Note: If two or more CPSEs/State PSEs participate in a tender, they will not be deemed to fall under the 'Conflict of Interest' provisions solely because they are under common control of Government of India/State Government.

## 14. Prevention of Corruption activities

A public procurement contract, besides being a commercial transaction, is also a legal Transaction and it is abide by Prevention of Corruption Act, 1988.

- (1) The Bidder(s)/ Contractor(s) commit themselves to take all measures necessary to prevent corr uption. The Bidder(s)/ Contractor(s) commit themselves to observe the following principles during participation in the tender process and during the contract execution:
- a. The Bidder(s)/Contractor(s) will not, directly or through any other person of firm, offer, promise or give to any of Principal's employees involved in the tender process or the execution of the contract, or to any third person any material or other benefit, which he/she is not legally entitled to, in order to obtain in exchange any advantage of any kind whatsoever during the tender process or during the execution of the contract.
- b. The Bidder(s)/Contractor(s) will not enter with other Bidders into any undisclosed agreement or, understanding, whether formal or informal. This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restric t competitiveness or to introduce cartelization in the bidding process.
- c. The Bidder(s)/ Contractor(s) will not commit any offence under the relevant IPC/PC Act; further t

he Bidder(s)/ Contractor(s) will not use improperly, for purposes of competition or personal gain, or pass on to others, any information or document provided by the Principal as part of the business relationship, regarding plans, technical proposals and business details, including information contained or transmitted electronically.

- d. The Bidder(s)/Contractor(s) of foreign origin shall disclose the name and address of the Agents/Representatives in India, if any. Similarly, the Bidder(s)/Contractor(s) of Indian Nationality shall fur nish the name and address of the foreign principals, if any. Further, details as mentioned in the "G uidelines on the Indian Agents of Foreign Suppliers" \*\* shall be disclosed by the Bidder(s)/ Contract or(s). Further, as mentioned in the Guidelines all the payment made to the Indian agent/representative shall be in Indian Rupees only. Copy of the "Guidelines on the Indian Agents of Foreign Suppliers" is attached.
- e. The Bidder(s)/ Contractor(s) will, when presenting their bid, disclose any and all payments made , is committed to or intends to make to agents, brokers or any other intermediaries in connection with the award of the contract.
- (2) The Bidder(s)/ Contractor(s) will not instigate third persons to commit offences outlined above or be an accessory to such offences.
- (3) If the Bidder(s)/Contractor(s), before award or during execution has committed a transgression through a violation of Para-1 & 2 above, or in any other form such as to put his reliability or credibility in question, the Principal is entitled to disqualify such Bidder(s)/Contractor(s) from the tender process or to terminate the contract, if already signed and to take action as per the procedure of "Banning of business dealings" of the Principal.
