## Special terms and conditions-Version:2 effective from 22-07-2025 for category De - Odorising - Cum - Disinfactant Fluids as per IS 10758

1. The product may also carry an ISI Mark/Standard Mark as per the BIS standard governing this category. As such Buyers may also opt for ISI marked product while creating BID. In such cases buyer shall verify valid BIS License for the same at the time of evaluation of BID and check ISI marking at the time of receipt of material before issuing CRAC.

#### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity  $\div$  Original quantity)  $\times$  Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

#### 2. Buyer Added Bid Specific ATC

- 1. The Bidder Must Submit Copy Of Organization / Firm Pan Number The Buyer Reserves the Rights for Any Changes/Cancellation/Rejection of Any Part or Whole Bid, Without Assigning Any Reason What So Ever.

- 5. Bidder / OEM Should Have Establishment for Minimum 3 Years and Proof Of Establishment Should Be Att ached With Seal And Sign Of Authorized Signatory.
- 6. A Undertaking Of The Same Should Be Given On Separate Letter Pad With Seal And Signature Of The Competent Authority.
- 7. Every Page Of Bid And All Document Attached With Bid Should Be Signed With Rubber Stamp Positively To Qualify The Technical Bid.
- 8. Only Those Suppliers Will Be Considered For The Bid Whose Sample To Be Approved By The Purchase Committee.
- 9. Only MP State Bidder Are Allowed To Participate In This Bid And If Other State Bidder Participated In This Bid So Bidder Is Not Liable For Financial Evaluation.
- 10. The Bidder/ OEM Will Upload Online Receiving Of The Documents And Sample By The Department And I f Receiving Not Uploaded So Bidder/OEM Will Be Rejected.
- 11. The Bidder/OEM Will Have 1 Year Old Service Center On Consignee Location.
- 12. The Bidder Is Required To Upload, Along With The Bid, All Relevant Certificates, Type Test Certificate,
- 13. Approval Certificates And Other Certificates As Prescribed In The Product Specification Given In The Bid Document.
- 14. All Generic And Additional Terms And Condition Should Be Printed On Letter Head Of Bidder With Sign And Stamp.
- 15. An undertaking on rupees 100/- non judicial stamp paper should be given by the Bidder that his firm Is not blacklisted by any government department or private organisation in last 5 years.
- 17. An undertaking on rupees 100/-non judicial stamp paper should be given by Bidder; that all the Inform ation provided are true and all the documents uploaded online all true
- 18. No extra charges towards transport, loading, unloading, installation, commissioning etc. will be given a bove the bid amount.
- 19. The bidder should not be charged any amount towards any replace, repair; commissioning etc. charge s within the warranty period. minimum one year warranty should be applicable on product and service .
- 20. the bidder only the original specification in the document will be accepted. Each and every page of all t he documents uploaded online should be duly sealed and signed by the Bidder . Scope of supply of goods and installation at the location.

### अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.

- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
