1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Certificates

ISO 9001: The bidder or the OEM of the offered products must have ISO 9001 certification.

3. Generic

Manufacturer Authorization:Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid

4. Buyer Added Bid Specific ATC

Responsibilities of the successfull Bidder:

a) The bidder should Supply, Install, Configure and commission Rovers within 03 weeks and train the officers & staff at Head office and regional offices.

b) The bidder should coordinate with OEM for any damage to the items within the warranty period and should get it replaced immediately and repaired within 07 days.

c) The bidder must provide details of service centers with Complaint Management System. It should have a full-fledged Service Desk which will be a Single Point of Contact (SPOC) for all the users. The Service Desk should receive all Complaints via Phone/Mail and provide satisfactory resolution.

d) The Bidder should furnish its Complaints Escalation Matrix, clearly indicating all Resolution Levels from bottom to top, Contact Persons with Contact Numbers/e-Mail IDs for each level.

Contract Agreement: The successful bidder has to execute agreement in Rs.100/- Bond paper within 10 days from the date of issuance of purchase Order in the form ap 8 / 11 proved by the Project Management Unit (PMU), NAKSHA Programme, UT of J&K as per the agreement annexure attached.

Information Sharing: Item description, make, model, items serial numbers, Date of supply, Date of warranty, Escalation Matrix are to be affixed in a sticker on individual unit and consolidated data shall be furnished to Project Management Unit (PMU), NAKSHA Programme, UT of J&K in excel sheet.

Penalty for delay in Supply and installation:

If the Supplier fails to deliver any or all of the Goods or to perform the Services within the period(s) specified in the Contract, the Purchaser shall, without prejudice to its other remedies under the Contract, deduct from the Contract Price, as liquidated damages, a sum equivalent to 0.5% of the delivered price of the delayed Goods or unperformed Services for each week or part thereof of delay until actual delivery or performance, up to a maximum deduction of 10% of the Contract Price. Once the maximum is reached, the Purchaser may consider termination of the Contract.

Any damages for the items within the warranty period should be immediately repaired or replaced within 7 government working days, else penalty of Rs. 100 per unit per day will be deducted from the PBG.

Any outstanding Penalty amount due on the date of submission of Invoice of items will be straight away deducted from the bill.

If there is no bill pending for payment, then the penalty amount will be encashed from PBG.

After satisfactory delivery and physical verification of all the ordered rovers, 70% of the payment shall be processed. Remaining 30% of the bill will be paid subsequently after successful training of the equipment usage to the satisfaction of user department Director Finance, Revenue, J&K is entitled to make recoveries of GST, TDS and penalties, excess payment and applicable taxes from bidder's invoice, if lawfully needed. In case of any change in rate of applicable GST, the difference of tax will be absolved by Director Finance, Revenue, J&K. The bidder shall submit completion certificate in proper manner required by this office. Incomplete submission of completion certificate will delay the payment.

Penalty cap: If the penalty for non-Delivery of Items crosses 10% of the tender value, the Department may decide to terminate the contract by forfeiting the Performance Bank Guarantee. Note: The above reports shall be duly signed with seal and signature of the authorized person where the hardware is delivered/ installed. (The documents shall be signed by the Head of concerned office).

Litigation

a) Amicable Settlement: The Parties shall use their best efforts to settle amicably all disputes arising out of or in connection with this Contract or the interpretation thereof.

b) Dispute Settlement: Any dispute between the Parties as to matters arising pursuant to this Contract which cannot be settled amicably within thirty (30) days after receipt by one Party of the other Party's request for such amicable settlement may be submitted by either Party for settlement to the Additional Chief Secretary, Revenue Department whose decision shall be final.

c) If either party is dissatisfied by (4a) and (4b) above, it may approach civil court, within the jurisdiction at Jammu, Jammu & Kashmir. 9 / 11 4)

Termination of contract:

Project Management Unit (PMU), NAKSHA Programme, UT of J&K reserves the right to cancel the contract placed on the bidder if:

- a) The bidder commits breach of any of the terms and conditions.
- b) The bidder goes into liquidation voluntarily or otherwise.
- c) The service is found unsatisfactory during the warranty period.
- d) The bidder supplies counterfeit/fake/damaged/substandard items.
- e) The OEM terminates the contract with bidder.
- f) The bidder wins the contract by misrepresenting facts relating to documents submitted for evaluation.

At any time prior to the date and time of submission of the tenders, Project Management Unit (PMU), NAKSHA Programme, UT of J&K may issue any amendment to this tender document

The bidder shall quote in Indian Rupees and the quoted prices shall be inclusive of all taxes, duties, statutory levies, supplying, installing, Commissioning, and forwarding and warranty cum maintenance of equipment supplied. Any Change in the quoted price is not allowed after the submission of the bid.

Miscellaneous Conditions:

1. Bidders can supply GNSS Rovers and Controllers of different OEMs. However, in such cases, the OEM of Network Rovers shall be responsible for complete integration of the equipment. The bids for single scheduled item of different OEMs may be treated as non-responsive offer. Further, the bidder should be responsible for submission of manufacturer authorization form for both GNSS Receivers and Controllers.
2. On-site training to 10 technical staff at each place of consignment will be provided by principal/Indian agents (if they have the requisite know-how) for operation and maintenance of the equipment to the satisfaction of the user department.
3. **ISO 9001:** The Bidder or OEM of the offered product must have ISO 9001 certification.
4. **Warranty:** Three years comprehensive (including spares and labour). All software updates should be provided free of cost during Warranty period.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
