27. CONTRACT PERIOD

The Contract shall be for a period of **12 months** from the date of issue of LOI/ Work Order, whichever is earlier. However the contract can be extended for a further **25%** with the same rate, terms and conditions at the discretion of HCL, MCP.

- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
