However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Service & Support

In the event where the distance travelled exceeds the monthly usage variant, amount will be paid for additional Kms as per schedule. Similarly, the unused Kms in a particular month as against the minimum guaranteed usage variant will be carried forward to the next month and additional Km if any in the next month shall be adjusted against this. However, the payment for the selected usage variant in a month will be paid every month." Further, the unused Kms in a particular month shall not be carried forward or adjusted beyond 6 months

3. Payment

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

Performance Guarantee: - Performance Guarantee at a rate of 5 % of the contractual value shall be deposited by the successful bidder. The successful bidder shall have to submit a performance guarantee (PG) valuing 5% of the contract value within 15 (fifteen) days from the date of issue of contract order. Extension of time for submission of PG beyond 15 days and up to the date of submission of PG from the date of issue of contract order may be given by the authority that is competent to sign the contract agreement. However, a penal interest of 15% per annum shall be charged for the delay beyond 15 days (i.e. 16th day after the date of issue of contract order). In case the contractor fails to submit the requisite PG after 60 days from the

date of issue of contract order, a notice shall be served to the contractor to deposit the PG immediately however not exceeding 90 days from the date of issue of contract order. In case the contractor fails to submit the requisite PG even after 90 days from the date of issue of contract order, the contract shall be terminated duly forfeiting EMD and other dues, if any payable against the contract. The failed contractor shall be debarred from participating in retender for this work. In case 60th day is a bank holiday or office closure next working day should be considered as the last day for submission of the PGs. Decision of authority competent to sign the contract agreement would be final in case of any dispute. The PGs shall be submitted in form of FDR/TDR, BG, Banker's cheque etc as considered fit by competent authority. The PG shall be submitted by successful bidder after issue of contract order but before signing of contract agreement. The PGs shall be initially valid up to stipulated date of completion and maintenance period, if any plus 60 days beyond that. In case, the time for completion of service gets extended, the contractor shall get the validity of PGs extended to cover such extended time for completion and maintenance period, if any of service plus 60 days.

In case of any discrepancy/ contravention between any conditions of scope of work or terms mentioned herein and GeM conditions, the terms conditions of scope of work & terms conditions mentioned herein shall prevail.

The bidders claiming exemption from submission of EMD on account of being MSME firm must ensure that they are registered for service under consideration. 13. **Buyer Added Bid Specific Scope Of Work(SOW)**

Text Clause(s)

The vehicle deployed by firm shall be BS-VI vehicle only, vehicle other than BS-VI can not be deployed by firm.

As the vehicle is required to travel to Delhi frequently, the firm must have permit for entry/ exit in Delhi. The firm will have to produce such permit (for both vehicles) prior to start of service. In case of non-availability of this permit firm will not be permitted to deploy vehicle to provide service under this contract. Further the firm shall ensure that such permit is valid during the course of contract and renewal, if required shall be ensured by firm well in time. Any failure to renewal or ensuring validity of permit shall make the contract liable for determination as per discretion of Railways.

A copy of all documents pertaining to vehicle and driver shall be submitted by contractor to consignee at the start of contract and shall be kept updated from time to time.

Firm shall read the scope of work as service is to be provided in accordance with terms stipulated therein. The contractor will have to abide all the conditions mentioned in scope of work.

The vehicle should have a functional Fastag and should have sufficient balance during journey as all the toll taxes, parking charges, octroi or any other municipal taxes or incidental charges are to be borne by contractor. Railway will not make any such payment to contractor for these.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
