1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Generic

Option Clause: Excess Settlement. The excess settlement has been enabled for the service, allowing service providers to include additional charges up to a specified percentage of the item-level total value, including addons, in their invoices. Service providers must declare the applicability of additional charges during invoice creation and submit mandatory supporting documents to avail this option. The total invoice amount, including additional charges, shall not exceed the agreed-upon excess settlement percentage for the order.

3. Buyer Added Bid Specific ATC

1. Eligibility Criteria-

2. Other Terms & Conditions

A) The firm must comply with GST Act, Income Tax Act and **Contract Labour (Regulation and Abolition) Act,**

B) Firm must provide police verification certificate of each provided staff before joining for work.

C) At the time of verification of hired manpower, firm must submit Original Degree/Certificates of the candidates.

D) **Profit margin or service charges of 3.85% (exclusive of GST)** is exclusive in the estimated bid value (letter No. F.6/1/2023-PPD (DA attached)).

E) Firm must adhere to Railway Board reservation policy for SC/ST/OBC and EWS applicable in engagement of contractual staff.

F) Contract will be valid for 1 year up to **30/12/26** or until availability of regular candidates through RRB or transfer.

Validity of contract may be extended for 6 months with mutual consent of both parties.

G) **Recovery Clause:** Cost of damage caused due to negligence/fault of contractor staff to railway property shall be recovered from contractor's bill.

H) Payment to contractor will be made only after getting proof of payment through bank to all deployed staff. Payment to staff deployed will be done through bank by the contractor.

I) Salary to deployed staff will be given max by **7th of every month**, irrespective of payment by railway.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer

is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
