**OPTION CLAUSE:** The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

#### 2. Scope of Supply

#### 3. Generic

Material Test Certificate Should Be Sent Along with The Supply. The Material Will Be Checked by Buyer's Lab & the Results of the Lab will be the Sole Criteria for Acceptance of the Item.

4. As per Govt. of India program (MEITY), The product manufacturer must have a manufacturing facility in India to promote "MAKE IN INDIA". Factory License, ISO 9001, ISO 14001, ISO 18001

5. bidder must submit a 5-year warranty certificate of Led streetlight.

6. manufacturer should have dedicated local service centers to provide quick responses against warranty.

7. Contractors/bidders shall be Authorized by the OEM and certificate for participating in the tender is mandatory to be enclosed with bid documents

8. All bidder are requested to upload all certificates such as Warranty, Esc matrix, Toll free no must have valid date or during tender tenure.

9. For technical qualification, bidders must provide one number of LED streetlight as a sample.

10. Both the manufacturer and the supplied product must be registered in the UP PWD CAT AAA Sor; submit it documentary evidence.
