If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. 3. 8. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are

validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

9. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. 10. Special terms and conditions-Version:1 effective from 03-05-2023 for category Split Air Conditioner (Ceiling Mount Type), as per IS: 1391 (part 2)

1. **STC FOR SPLIT AIR CONDITIONER**

Central Ministries/ Departments while procuring electrical appliances notified by the Department of Expenditure (DoE) shall ensure that they carry the notified threshold or higher Star Rating of the Bureau of Energy Efficiency (BEE). In this regard, DoE OM No.26/6/2012-PPD dated 21.01.2013 may also be referred to wherein appliances and threshold star ratings have been circulated.

Scope of installation and Commissioning for Ceiling Mount / Cassette AC

- (1) Mounting/Fitting of indoor and outdoor units at the respective locations after cutting the false ceiling/drilling holes into the roof, if required.
- (2) Laying of refrigerant piping and connecting with indoor and outdoor units after drilling hole/holes in the wall (all type of walls), if required.
- (3) Checking / Charging Refrigerant gas in the unit.
- (4) Suitable electric wiring between indoor units and switches up to 3 meters in length.
- (5) Testing for satisfactory working without any abnormal noise as well as leakage test of entire system.

The following are not included in the scope of supply for Ceiling Mount / Cassette AC:

- (1) Refrigerant pipe of the required length.
- (2) Set of 4 nos. of Rods for fixing Cassette AC to the roof.
- (3) Chiselling / Ducting / grooving for concealing the Refrigerant piping/cabing.
- (4) Switches/ Sockets / Plug Tops / Voltage Stabilizer./ Stand for ODU/Drain pipe/Angles.

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. 4. **OEM**

IMPORTED PRODUCTS: In case of imported products, OEM or Authorized Seller of OEM should have a registered office in India to provide after sales service support in India. The certificate to this effect should be submitted.

5. **Financial Criteria**

NET WORTH: Net Worth of the OEM should be positive as per the last audited financial statement.

6. **Scope of Supply**

Scope of supply (Bid price to include all cost components) : Only supply of Goods

7. **Turnover**

Bidder Turn Over Criteria: The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. 8. **Turnover**

9. **Service & Support**

If service center is not already there at the time of bidding, successful bidder / OEM shall have to establish one within 30 days of award of contract. 12. **Warranty**

Timely Servicing / rectification of defects during warranty period: After having been notified of the defects / service requirement during warranty period, Seller has to complete the required Service / Rectification within 10 days time limit. If the Seller fails to complete service / rectification with defined time limit, a penalty of 0.5% of Unit Price of the product shall be charged as penalty for each week of delay from the seller. Seller can deposit the penalty with the Buyer directly else the Buyer shall have a right to recover all such penalty amount from the Performance Security (PBG). Cumulative Penalty cannot exceed more than 10% of the total contract value after which the Buyer shall have the right to get the service / rectification done from alternate sources at the risk and cost of the Seller besides forfeiture of PBG. Seller shall be liable to re-imburse the cost of such service / rectification to the Buyer.

13. **Past Project Experience**

Proof for Past Experience and Project Experience clause: For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria: a. Contract copy along with Invoice(s) with self-certification by the bidder that service/supplies against the invoices have been executed. b. Execution certificate by client with contract value. c. Additional Terms and Conditions for Supply of Air Conditioners

1. Scope of Supply

1.1 The Supplier shall provide the air conditioning units, components, accessories, and installation materials as specified in the Purchase Order.

1.2 Any items not expressly listed in the Purchase Order shall be considered exclusions unless otherwise agreed in writing.

2. Delivery and Installation

2.1 Delivery dates are estimates and subject to availability of stock and logistics.

2.2 The Supplier shall deliver the units to the installation site during normal working hours unless otherwise agreed.

2.3 The Customer shall ensure that the installation site is accessible and prepared, including provision of electrical supply points and necessary clearances.

2.4 Delays caused by site inaccessibility or lack of readiness shall be chargeable to the Customer.

3. Electrical Requirements

3.1 The Customer is responsible for ensuring that the existing electrical system complies with the required voltage and load requirements of the air conditioners.

3.2 Any electrical upgrade or additional wiring required shall be charged separately.

4. Warranty

4.1 Manufacturer's warranty shall apply as per the official warranty terms of the unit.

4.2 Warranty shall not cover:

- **Damage caused by improper use, mishandling, or unauthorized repairs**
- **Environmental conditions such as corrosion, pests, or flooding**
- **Power surges or inadequate electrical supply**

4.3 All warranty claims must be accompanied by proof of purchase and serial number details.

5. Maintenance

5.1 Preventive maintenance services are not included unless stated otherwise.

5.2 The Customer is responsible for regular cleaning of filters and general care as recommended by the manufacturer.

5.3 Failure to maintain the units may void the warranty.

6. Payments

6.1 Payment terms shall be as stated in the Purchase Order or Invoice.

6.2 Late payments may incur interest charges at the rate specified in the Invoice or as permitted by applicable law.

6.3 The Supplier reserves the right to withhold delivery or installation until payment conditions are met.

7. Returns and Replacement

7.1 Returns are accepted only for goods found to be defective upon delivery and confirmed by the Supplier.

7.2 Units installed and used cannot be returned unless covered by warranty replacement.

7.3 Replacement timelines depend on manufacturer availability.

8. Limitation of Liability

8.1 The Supplier shall not be liable for indirect, incidental, or consequential damages, including loss of profits or business interruption.

8.2 Total liability shall not exceed the total price paid for the units supplied.

9. Health and Safety

9.1 The Supplier will follow standard industry safety procedures during installation.

9.2 The Customer must inform the Supplier of any hazardous conditions at the site.

10. Compliance

10.1 All supplied equipment shall comply with applicable energy efficiency, environmental, and safety regulations.

10.2 The Customer is responsible for obtaining any building or municipal permits required for installation.

11. Ownership and Risk

11.1 Ownership of the goods passes to the Customer upon full payment.

11.2 Risk of loss or damage passes to the Customer upon delivery to the site.

12. Force Majeure

Neither party shall be liable for delays caused by events beyond reasonable control, including natural disasters, strikes, or supply chain disruptions.

13. Governing Law

These terms shall be governed by the laws of the jurisdiction specified in the Purchase Order or Agreement.
