1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Generic

Option Clause: Excess Settlement. The excess settlement has been enabled for the service, allowing service providers to include additional charges up to a specified percentage of the item-level total value, including addons, in their invoices. Service providers must declare the applicability of additional charges during invoice creation and submit mandatory supporting documents to avail this option. The total invoice amount, including additional charges, shall not exceed the agreed-upon excess settlement percentage for the order.

3. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

4. Service & Support

1. SERVICE SCHEDULES INCLUDES:

- Break down call will be attended on priority basis within 24 hrs from date of intimation.
- Preventive maintenance of complete system will be carried out on quarterly basis as per OE
 M
- Inspection of all equipments as per OEM.

2. CHILLERs:

- Checking the functioning of chiller and taking a set of readings and evaluating the same to ensure the satisfactory performance of the plant.
- Review the control panel for proper operation & record fault histories.
- Inspecting entire system for unusual conditions such as noise, vibration, etc.
- Checking the system operating pressure and temperatures to ensure proper operating conditions.
- Comparing the chilled water temperature at full load with the chilled water temperature con trol.
- Inspecting and adjusting, if required, of all safety controls.
- Inspecting all operating control and sequence of operation.
- Inspecting starter contacts are shield, transformer, and motor terminals.
- Check connection in starter; tighten motor terminal control circuit terminals.
- The system will be serviced four times in the contract period.
- The compressor will be checked for its proper functioning and if any defect is found, the sam
 e will be rectified. The defective spares for the system will be replaced and consumables lik
 e refrigerant gas will also be supplied by us whenever necessary.
- The entire refrigeration system will be checked for any leak and attended too if necessary.
- Safety controls such as pressure cut outs will be tested for proper functioning and in case of any malfunctioning; they will be either repaired or replaced accordingly.
- Any defect in the electrical items and control wiring will be attended too.
- Check the liquid sight glass to determine the refrigerant level, if there is any refrigerant shor tage in system.
- Checking the starter & contactors and transformer & cleaning the same. If necessary, the same will be replaced.
- Inspection of all equipment's will be conducted apart from servicing.

3. **COOLING TOWERs:**

- Checking of cooling tower hub assembly for normal operation.
- Cleaning of cooling tower sump, spray nozzle and cleaning of cooling tower fills externally.
- Checking of cooling tower fan motor/blade for proper functioning.
- External cleaning of cooling tower fills will be carried out four times in a year.
- Checking the fan blades for defects and cleaning if required.

4. PUMPs:

- Checking pump & motor alignment.
- o Checking voltage of pump motor.
- Greasing bearings of pump & motor.
- Checking for pump vibration/abnormal noise.
- Checking the pressure/temperature gauges.

- Checking starter controls of pump motor and clean any shielded contacts.

III. TERMS AND CONDITIONS:

- 1. Your offer should be valid as per GeM.

Insurance & all other incidents are in your scope to the extent of his liability under wo rkmen's compensation ACT 1923 & others. BDL is not responsible for any direct or indirect a ccidents to your service personnel. Vendor has to arrange all the necessary safety devices li ke, Helmets, safety shoes, etc for carrying out the entire work.
- 5. Contractor has to depute OEM's engineer at site for Preventive maintenance and Breakdow n maintenance by intimating one day advance to Shift Engineer.

IV. PAYMENT CONDITIONS:

- 1. Payment terms: Pro-rata Payment will be paid after successful completion of the subject wor k and submission of GST Invoice along with service visit report duly signed by Engineer-in-c harge on Quarterly
- 2. BDL reserves its right to release GST only after supplier's invoice/debit note is reflected in G STR-2B/2A within the specified time limit mentioned in GST law.
- 3. Offer has to specify the applicable taxes, and other terms & conditions.
- 4. L.D.Clause: BDL may also deduct from the vendor as agreed, liquidated damages to the sum of 1/100 of the delay percentage{Delay percentage = (period of Delay in Delivery in Weeks) x 100 / (Delivery Period in weeks as per contract)} of the PO/Contract price of the delayed/u ndelivered stores/ services mentioned above for every week of delay or part of a week, subject to the maximum value of the Liquidated Damages being not higher than 10% of the PO/Contract price of the value of delayed stores/services.GST extra is applicable on Liquidated damages.
- 5. Statutory deductions as applicable will be deducted while releasing the payment.

V. ELIGIBILITY CRITERIA:

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to

- exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to gualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
- 16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
