1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Payment

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

3. Buyer Added Bid Specific ATC

1. **The Firm/Agency/Bidder must be Registered with labour Department at Chandigarh and Valid Registration Certificate shall be submitted along with Technical Bid if required.**
2. The service provider/bidder (individual/firm/company) should be not be black listed / prosecuted by any Central / State Governments / Union Territories / Departments / Offices / Statutory / Bodies / Autonomous / Organizations/ Research institutions/any court of law. 3. Availability of office of Service Provider: An office of the Service Provider/ Bidder must be located in the Tricity i.e., Chandigarh, Mohali and Panchkula. Documentary Evidence to be submitted along with Bid documents.
4. **Deployment of existing working/deployed resources (Manpower):** **Number** of existing working/ deployed resources of the procurement department having job 'satisfactory certificate, will be continued by the successful service provider under the new contract also-subject to their consent to the terms and conditions of new contract concluded on the basis of this bid. **(As per Letter No. 19/C2/2021/PEO (GEM) /885 dt. 25.10.2021 from the office Finance & Planning officer, Finance Secretary Chandigarh Administration).**
5. The AD is informed that before notification dated 22.05.2015, Matric was not prescribed as qualification for the post in question). The said notification dated 22.05.2015 issued by the Engineering Department, Chandigarh Administration prescribed qualification for the post of Trade mate (in question) as Matric. The said notification is applicable prospectively. The outsourced employees engaged before 22.05.2015 cannot be governed by the higher qualification prescribed in the notification. Hence such outsourced persons engaged before 22.05.2015 need to be removed merely on the grounds of lack of qualification (Matric). **(As per letter of Superintendent Personnel Chd. Admn. 6. **Prohibition from seeking deposits or security amount:** Seeking any deposits or security amounts from the deployed resource or any other form of monetary acceptance by the service provider is strictly prohibited. If any such complaint is received, an incident will be raised on GeM portal for suitable action as per incident Management policy GeM. In addition buyer department may separately initiate suitable penal action as per their laid down norms. **As per letter No. 19/C2/2021/PEO (GEM)/885 dt. 25.10.2021 from the office Finance & Planning officer, Finance Secretary Chandigarh Administration).**
7. The firm/bidder must have completed the similar of following magnitude during last 3 Years ending last day of month previous to month of bid.

- c. One similar order each of value not less than 80% of the estimated bid value.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid.
