1. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

4. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

5. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. **Generic**

Option Clause: Excess Settlement. The excess settlement has been enabled for the service, allowing service providers to include additional charges up to a specified percentage of the item-level total value, including add-ons, in their invoices. Service providers must declare the applicability of additional charges during invoice creation and submit mandatory supporting documents to avail this option. The total invoice amount, including additional charges, shall not exceed the agreed-upon excess settlement percentage for the order.

3. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

During the contract the client shall not allow any other firm company or individual other than that of the Company to repair or service or handle the machine in question in this Contract. In case of breach of this trust, all amount or amount paid to the company shall stand forfeited and no claim what so ever shall be entertained.

3.

Under the contract, the company shall depute. Its representative to service to service the machinery. The representative shall open the machine including its critical moving parts and shall clean and service them properly as required. The representative shall ensure smooth Working of the machine and shall obtain a certificate of satisfactory service from the client after the service is carried out on the machine on each occasion of the contract.

4.

In case of defective working of machine, the company may at its own will, rectify the faults even if the service is extra to the scheduled four services. However, in case the defect is due to mishandling, careless operation or due to replacement of parts already recommended, the company shall not be responsible for the malfunctioning of the machines. Minor spare parts (including keyboard, mouse, connecting cables, data cables, replacements, connecting parts) etc shall be replaced by the vendor as part of routing maintenance schedules services and/or repair during course of normal complaints. Antivirus or any other software provided by this HQ is also required to be installed by the vendor whenever asked.

5.

Technical advise shall be given by the vendor for all unserviceable computers to include on - site assessments, identifying parts to be replaced/ upgraded and make cost assessment of repairs /replacement renewals of peripherals and parts not covered under Para 6 above.

SCHEDULED SERVICES

All machines shall be serviced once in three months to include:-

General replacement servicing checking potential faults.

(b)

Install OS updates, antivirus, upgrades and updating drivers for printers/scanners/ fax machines or any other authorized IT peripherals.

(c)

Removing potentially harmful viruses/ Trojans/ threats from the operating system hard drives.-2-

Partitioning of hard disk and locking utilities as per Army Cyber Security Policy 2017 to viz Disabling USB drives, disabling internal CD/DVD writers of PCs, disabling Wifi access etc as orders updated from time to time.

7.

Initial commissioning of newly procured computers and peripherals including operating system installation, updates/ patches and integration into HQ CWE Amritsar network and Configuring of printers/ scanners/ fax machines on the PC.

#### REPAIRS & EMERGENCY SERVICES

Routine maintenance under this contracts any dysfunctions/failure of the machine. Penalty clause when reported, will be attended within 24 hours of receipt of repair call from HQ CWE Amritsar, Old Amritsar Cantt.

9.

The machine shall be serviced on any working day scheduled services (Quarterly) under the contract.

10.

There being heavy load of complaints, 01 x technician will be deputed on all working days and 01 x technician for carrying out scheduled service and Emergency services mentioned above. The technicians shall be responsible for proper administration of local area network (LAN) in CWE office and enforcing under hygiene measures in all computers. Rs 600/- per day will be levied , in case of absence.

11.

If vendor unable to repair the PC/Printer/UPS in the office premises and want take the same to his workshop for repair, then it is responsibility of the vendor to provide alternative PC/ Printer/ UPS

for smooth functioning of office work till the PC/Printer/UPS get repaired.

2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
