### 1. **Generic**

### 2. **Generic**

Service providers must declare the applicability of additional charges during invoice creation and submit mandatory supporting documents to avail this option. 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.
