Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.

5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
