  3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

### 6. **Generic**

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 50 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 50 percent. Bidders are bound to accept the revised quantity or duration.

### 7. **Buyer Added Bid Specific ATC**

1. Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.

  - ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
  - iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
  - iv) The Seller becomes bankrupt or goes into liquidation.
  - v) The Seller makes a general assignment for the benefit of creditors.
  - vi) A receiver is appointed for any substantial property owned by the Seller.
  - vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.
5. While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.
6. The bidders who fail to respond to the clarifications sought within the stipulated time, will be rejected.
7. Failing to comply to any of the enquiry parameters, such technical bids will be rejected.
8. Buyer reserves the right to cancel the bid at any given point of time.
