4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. - 2. Your rates should be inclusive for the free delivery/repair/replacement amend ment of works and the various taxes including GST.
- 3. Bids received will be opened by the **buyer** at office of the GE (AF) Jamnagar No 1. Technical evaluation of bid will be done as per the conditions and various doc uments required as mentioned in ATC. Non observance of those conditions may make your bid invalid and unacceptable.

SPECIFIC CONDITIONS

- 1. Old retrieved materials will be the property of the vendor as schedule of credit already detected.
- 2. The work should be guaranteed for one year after completion of the works/ repairs.
- 3. After award of the job work/repair should be done immediately but not later then the **date fixed in the contract**.
- 4 Rates should be offered as per specification of description mentioned in Scope of Work.
- 5. Rate should be inclusive of all contingencies. Rates should be of delivery at site of **AGE E/M-II (E&R)** under Garrison Engineer (AF) Jamnagar No 1 PIN-361003.
- 6. Garrison Engineer (AF) Jamnagar No. 01 reserves the right of accepting or rejecting of quotation without assessment and reasons thereof.
- 7. On receipt of order to carry out the works/ repairs, if you fail to comple te work, in accordance with the above conditions GE (AF) Jamnagar No 1 reserves the right to carry out the same elsewhere or by other agency under your risk and cost.
- 8. If the work as shown in conditions above cannot be carried out, you should give alternative date for completion of the repairs.
- 9. The department reserves the right to cancel your agreement as and when y our services seem to be unsatisfactory.
- 10. The firm will carry out the Job Work / delivery of items in site located at **AGE E/M-II (E&R)** of GE (AF) Jamnagar No. 01.
- 11. The rates quoted and accepted are for receipt, installation and Job Work in acc ordance with conditions 2 and 3 mentioned above loading in to public carries/repaire rs vehicles or unloading from public carrier/repairers vehicles or unloading from public carrier/repairers vehicle at the consignee's and shall be sent by the department re pairer at its own cost.
- 12. All stores required for Job Work be provided by the firm at his own cost and h is rates shall be deemed to include the cost therein.
- 13. The firm will provide all material/spares required for the testing of the item or dered and his rates would be deemed to include the cost thereof.
- 14. The firm shall only be the custodian of the items handed over to it for Job Work while ownership and all other rights on the item is of the department.
- 15. If the Job Work is excepted to be delayed due to any cause beyond your control, you shall immediately on the happening of the event causing delay in Job Work give notice thereof in writing to the accepting officer under intimation to the consignee who after consideration of circumstances causing delay in the repairs may grant reasonable extension of time for completing Job Work.
- 16. In case the Job Work is not completed within the stipulated time the order may be cancelled and the items taken back without any liability, what so ever towar ds the department.
- 17. Payment will be made to Supplier/Firm only after satisfactory completion of Job Work and submission of bill pre-audited and passed for payment.
- 18. The supplied Stores/items should be guaranteed against/manufacturing defects for a period of **one year** from the date of supply. The supplier undertakes to repair/replace the defective items up to the period specified as above.
- 19. The Supplier/ firm shall contact Engineer-in-Charge for the purpose of inspection of site and relevant documents. The Supplier/firm shall also make himself famili ar with working conditions, accessibility of site, availability of materials and other cogent conditions which may affect the completion of work. The Supplier/firm shall be deemed to have visited the site and made himself familiar with working conditions whether he actually inspect the site or not.
- 20. Registration / Empanelment Requirement : Contract shall be awarded to only s uch sellers, who are registered / empanelled / approved/ enlisted/ working experienc

e with MES for the required goods / service category on the date of bid opening. Pros pective bidders (if not already registered), are advised to get themselves registered with the said registration authority before bid opening date. (It is certified that the re gistration is granted by the registering agency as per Rule 150 of GFR following a fair , transparent and reasonable procedure.

Garrison Engineer (AF) Jamnagar No 1 or his authorized representative Board s of officers will inspect the Works/ Repair done by you and his findings will be final f or acceptance.

22. You or your representative must be present at the time of inspection of job works/ repairs carried out by you.
23. **EMPLOYEES PROVIDENT FUND**

- (a) The contractor shall have provident fund code number. Any sub-contractor engaged by him shouldalso have provident fund code number.
- The contractor shall ensure that all the workers deployed during the ex (b) ecution of work are enrolled as members of provident fund and should be give n the Universal Account Number (UAN). The contractor shall submit relevant p articulars to the GE on asked for.
- While claiming any payment, the contractor shall submit the certificate that all workers employed directly or indirectly by him are registered for EPF a nd due contributions have been credited into their account.

24. **SECURITY AND PASSES**

- 24.1 Refer Condition 25 of IAFW-2249. The contractor shall employ only Indian Nat ionals as his representatives, servants and workmen and verify their antecede nts and loyalty before employing them for the works. He shall ensure that no p erson of doubtful antecedents and nationality is in any way, associated with w ork. If for reasons of technical collaboration or other consideration, the employ ment of any foreign national is unavoidable, the contractor shall furnish full pa rticulars of this effect to the Accepting Officer at the time of submission of his t ender.
- The contractor shall, on demand by the Engineer-in-Charge, submit list of his agents, employees and work people concerned and shall satisfy the Engineer-in-Char ge as to the bonafides of such people.
- 24.3 The Engineer-in-Charge shall at his discretion have the right to issue passes a s per rules and regulations of the installation/area in force to control the admis sion of the contractor, his agents, employees and work people to the site of th e work or any part thereof. Passes should be returned at any time on demand by the Engineer-in-Charge of the authorities concerned and in any case on completion of work.
- 24.4 The contractor and his agents, employees and work people shall observe all t he rules promulgated by the authority controlling the installation/area in which the work is to be carried out e.g. prohibition of smoking and lighting, fire preca utions, search of persons on entry and exit, keeping to specific routes, observi ng specified timing etc. Nothing extra shall be admissible for any hours etc, lo st on this account.

25. **Identity cards or passes**

The contractor, his agents and representative are required individually to be in possession of any identity cards or pass duly verified by the Garrison Engineer.

The security staff will examine the identity card or pass at the time of entry i nto, exit from the Restricted Area and also at any time or number of times insi de the Restricted Area.

25.1 <u>Identity of workmen</u>

Every workman shall be in possession of an identity card. The identity card will be issued after through investigation of the antecedents of the labourers by the contractors and attested by the Officer-in-Charge of the unit concerned in accordance with the standing rules and regulations of the units. Contractor shall be responsible for the conduct and action of his workmen, agents or representatives.

25.2 Search

Through search of all persons and transport shall be carried out at each gate a nd for as many times as gate is used for entry or exit and may also be carried out at any time or any number of times at the work site within the Restricted A rea.

26. **STANDARD AND QUALITY OF WORK**

The entire electrical work under this contract shall be carried out in strict comp liance with these specifications and inconformity with the provisions contained the latest Edition (including amendments) of Indian Electricity Supply Act 1948 and Indian Electricity Rules 1948 as amplified and enforced by the Gujrat State Government. All electrical works shall be carried out by properly skilled electricians under supervision of suitable qualified supervisors. As per latest practice and latest IS code / IS Rules. The contractor shall produced such evidence of qualification of his workman / supervisor either at commencement of work / or a t any time there after on demand by Engineer-in-Charge. Approval of samples shall be in writing. Approved sample shall be labeled as such signed by both the contractor and Engineer-In-Charge and kept in the custody of the Enginer-In-Charge till the completion of the work.

27. **REPAIR OR REPLACEMENT GENERALLY:**

Repair/replacement shall generally include,(a) disconnecting (b) dismantling of parts,(c) carrying out repairs specified ,and / or replacement, (d) overhaulin g by cleaning and oiling or greasing, re-assembling of units,(e) initial testing b efore fixing,(f) refixing of equipments at the position including cleaning and ne cessary repairs to base / position,(g) replacement of bolts, nuts as required,(h) any all other petty works essential for smooth working of equipment and (j) testing of equipment at full load. All these operation shall be carried out as direct ed by Eingineer-in-Charge and to his entire satisfaction.

- 27.1 Taking out and dismantling of parts of equipment should be done using prop er tools and with special care. Any damage caused due to mishandling of the equipment will be made good by the contractor without any extra payment.
- 27.2 The rate quoted by the tenderer in Sch 'A' shall be deemed to included mino r repairs such as fixing of screws (any type), welding of sheet polishing, denting etc. If required to be carried out to complete the work.

PAYMENT INSTRUCTIONS

1. Payment shall be made on completion of the job works/repairs by the authori

zed representative detailed by the consignee or his superior HQ.

- 2. On completion of job works/Repairs, the vendor will be required to submit his invoice. Payment will be made through CMP Fund Transfer hence it is requested to submit your Bank Account details in case it is necessary.
- 3. Copy of the contract order will be attached with the bill.
- 4. Where GST in charged, the vendor will quote his GST Registration Number.
- 5. Payment will be made to the vendor account by CMP Fund Transfer.
- 6. The quoted rate should include all the taxes including GST.

DOCUMENTS TO BE UPLOADED FOR TECHNICAL EVALUATION

- 1. Copy of registered / empanelled / approved/ enlisted with MES for the re quired goods / service category on the date of bid opening. Prospective bidders (if not already registered), are advised to get themselves registered with the sa id registration authority. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the

- case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
- 16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
