1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

3. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

5. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 10% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Scope of Supply

Scope of supply (Bid price to include all cost components) : Supply Installation Testing and Commissioning of Goods

3. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

4. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. The bidder must upload copies of Income Tax Returns (ITR) for the last three years with the bid documents.
2. The OEM must have a valid UP PWD AAA certificate for offering High Mast Octagonal Poles / LED street light products. The certificate, annexure, and list of approved product models in PWD must be attached with the bid documents.
3. The bidder must be authorized by the OEM to offer products (both High Mast Octagonal Poles and street lights). The authorization certificate, including the bid number and date, must be enclosed with the bid documents.
4. LM79 report, technical data sheet, and BIS certificates for LED street lights and their drivers must be enclosed with the bid documents.
5. The bidder must upload the OEM's "Make in India" certificate for the offered products (both High Mast Octagonal Pole and street lights). The minimum local content in the offered product should be at least 50%.
6. It is compulsory to upload the OEM's factory license (for poles and lights) along with the bid documents.

7. The OEM company must have an in-house NABL testing facility for testing LED street lights. The certificate and scope must be enclosed with the bid documents.

8. The bidder must submit a declaration on a notarized ₹10 stamp paper stating that their firm has not been blacklisted, debarred, or banned by any government, semi-government, or PSU department. The Issued Date Of The Stamp Is As Per The Bid /Tender Date In Last Three Years. If the declaration is found false or manipulated, the bid will be cancelled, and appropriate action will be taken.

9. The OEM of the offered LED street light products must submit a declaration on a notarized ₹10 stamp paper stating that the OEM company has not been blacklisted, debarred, or banned by any government, semi-government, or PSU department in the last three years. False or manipulated declarations will lead to bid cancellation and action against the OEM.

10. A five-year replacement warranty for LED street lights on OEM letterhead, mentioning the bid number, must be enclosed with the bid documents.

11. The price list of the offered LED Flood light products must be enclosed with the bid documents.

12. The bidder must submit a ₹10 stamp paper along with a revenue Ticket.

13. The bidder must submit a ₹10 stamp paper self-declaration along with a photograph.

14. It is compulsory to upload the experience details of the bidder or OEM.

15. Bidder should submit amount- 40000/- Only RTGS Accepted in favour of "Executive Officer Nagar Palika Parishad Khair District Aligarh in A/C No. 39024102644. IFSC Code: SBIN0002387, STATE BANK OF INDIA. Scanned copy of Security with transaction Id certified by the same bank must be enclosed along with the Gem Tender Document & There Is no Discount For MSME Certificate.

16. The bidder/firm must attach the net worth certificate issued by a Chartered Accountant (CA) with the bid documents.

17. The bidder must upload the E-mandate form duly signed by the bank and the bidder.

18. A liquid assets certificate issued by the bank, showing 5% of the bid value, must be attached with the bid documents.

19. The bidder or OEM must have ISO 9001:2015 certification, which must be attached with the bid documents.

20. It is compulsory to upload the character certificate of the bidder, issued by the District Magistrate.

21. The bidder must submit the product specification on a notarized ₹10 stamp paper.

22. The bidder or OEM must compulsorily upload the last three years' CA turnover certificate.

23. The LED street/Flood light manufacturer must be registered with the Ministry of Science & Technology, Government of India.

24. It is compulsory to upload PAN, and GST certificate.

25. The LED street light manufacturer should be ISO 9001 and ISO 14001 certified.

26. The value of work will increase or decrease based on the site conditions.

27. Work will be done according to the estimate.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent

Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**

- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider.
