Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within $L-1+15\%$ of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised

quantity or duration

2. **Generic**

Option Clause: Excess Settlement. The excess settlement has been enabled for the service, allowing service providers to include additional charges up to a specified percentage of the item-level total value, including addons, in their invoices. Service providers must declare the applicability of additional charges during invoice creation and submit mandatory supporting documents to avail this option. The total invoice amount, including additional charges, shall not exceed the agreed-upon excess settlement percentage for the order.

3. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

4. **Payment**

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

5. **Forms of EMD and PBG**

Successful Bidder can submit the Performance Security in the form of Fixed Deposit Receipt also (besides PBG which is allowed as per GeM GTC). FDR should be made out or pledged in the name of

Sr. DFM/BPL/WCR

A/C (Name of the Seller). The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. For release of Security Deposit, the FDR will be released in favour of bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter. Successful Bidder has to upload scanned copy of the FDR document in place of PBG and has to ensure delivery of hard copy of Original FDR to the Buyer within 15 days of award of contract.

6. **Buyer Added Bid Specific ATC**

Buyer added additional condition for GEM Contract

1. Hiring of TRUCK, (02 Nos) Open body 13 Ft.LCV Truck is required for the section of **SSE/PW/GUNA & SSE/PW/ASKN** for a period of 36 months (i.e. 1095 days) with monthly running upto 2000KM per month per truck.

2.Truck will have to be made available according to the requirement and demand of the Railway Administration from 00.00 to 24.00Hrs from the date of the acceptance letter or as advised by the railway in LOA. The vehicle will be permitted to be withdrawn for servicing and maintenance etc. only after an alternative vehicle should be made available during that period.

3.Truck should be mechanically sound and shall be maintained decently and should be capable of running on kachcha road also. The driver should possess good behavior and be neatly dressed.

4. The Truck should be self-starting in good running condition and model year of the truck should not be more than **Five years old i.e 2020**.

5. The Truck should be available for any outstation duty during the contract period. The Toll Charges and other taxes for the outstation duty will be paid by the contractor.

6.Working of the railway is 24x7,hence driver may be called at any time in emergent situation. Contractor must ensure availability of driver whenever they are called.

7. The logbook will be filled by SSE/In-charge on daily basis with signatures.
8. The bill will be verified by **ADEN/ GUNA** before sending to DRM(W) Office at Bhopal.
9. During the working period, the Truck may be Parked at the stipulated office premises as per the discretion of Concerned SSE/Pway/In-charge.
10. All consumables like Petrol /Diesel, mobile oil and expenses like toll tax, entry tax etc. for the use of the vehicle along with the salary of driver from the time of hire shall be provided by Owner of vehicle at his own cost.
11. Contractor shall be responsible for any repair, accidental, loss, damage etc. to the vehicle as well as to driver due to any mishap, accident etc. during the period of hire.
12. In case vehicle goes out of order an alternate truck must be arranged within a reasonable time not exceeding 12 hrs. All relevant document of the alternate vehicle to be made available before bringing vehicle for run. This shall be checked by **ADEN/ GUNA**.
13. All Document including competency of driver must be available on the vehicle.
14. The expenditure on routine maintenance, comprehensive insurance, registration and road tax etc. Shall be borne by the contractor.
15. In case of any defects got developed and are pointed out by Railway Authority, necessary repairs and replacement should be carried out immediately by the contractor at his own cost.
16. The contractor should fulfill all statutory requirements with respect to labor laws like minimum wages to driver, PF, ESI etc. He/she will bear all liability in terms of Workman's Compensation Act in case of accidents/inquiry of his employee.
17. The evaluation of the bid will be done as per the criteria uploaded by the Railways.
18. The billing of truck will be done on monthly basis. However, if the truck runs for shorter KMs than monthly slab in a month, the balance KM shall be carried forward to the next month and the revised monthly slab of next month shall be the sum of original monthly slab as per the bid and the balance km carried forward from previous month as mentioned above. For example, the monthly slab in the instant bid is 2000 km/month and the vehicle running in a month is only 1700 km then the balance 300 km shall be carried forward to next month and the revised monthly slab of next month shall be 2300 km (2000km+300km) instead of 2000km/month and this will be carried out through next Three months.
19. Tenderer shall necessarily indicate following Details regarding offered vehicle: -
- (i) Type of vehicle (preferred vehicle) (ii) Year of Model (as per para) ·
 - (iii) Fuel used (whether Diesel or petrol drive) (iv) State passing
 - (v) Registration Certificate (vi) Pollution Certificate
 - (vii) Insurance of Vehicle
 - (viii) Any other document which is necessary as per latest norms.
- 20. Payment terms, Penalties, Extra km's Charges will be as per the GEM conditions.**
- 21. Variation upto 125% , shall be applicable as per GEM 25% option clause condition and beyond 125% , GCC for services 2018 Para 5.3.3 & 5.3.4 shall be applicable.**
- 22. In case of any dispute regarding the scope of work and any other condition of contract the decision of Tender Accepting Authority will be final.**
23. Submission of Annexure-I is mandatory and non-submission of Annexure-I by the bidder shall result in summarily rejection of his/their bid.

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
