3. **Generic**

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

4. **Generic**

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

5. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

6. **Service & Support**

8. **Payment**

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

5. The cost of contract shall be valid for initial contract period. No price escalation, other than minimum

6. The bidder must have ISO 30409 and ITO-7101:2023 certification a copy of the same to be attached.
 7. The Bidder should give undertaking on **legal stamp paper of Rs. 1000/-** (stamp paper purchased date on or after publishing of Bid date) that the bidder has not been blacklisted with any of the Central Government Department and any State Department/PSU/Banks & Financial institutions on account of corrupt or fraudulent practices from F.V. 2014-15 till date.
 8. Pre Bid meeting is compulsory as per details mentioned in GeM.
