- 1. 1. <u>Note to Sellers</u>: 'Standard Length of Rope Light per Pack (in meters)' has been specified in the technical particulars for understanding of standard length of rope light in a pack. However, the price to be quoted by the seller only for per meter of Rope Light.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity ÷ Original quantity) × Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Scope of Supply

Scope of supply (Bid price to include all cost components) : Supply Installation Testing and Commissioning of Goods

3. Service & Support

Availability of Service Centres: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty). If service center is not already there at the time of bidding, successful bidder / OEM shall have to establish one within 30 days of award of contract. Payment shall be released only after submission of documentary evidence of having Functional Service Centre.

- 5. OEM must have ISO 9001 certification, Same need to upload with bid documents.
- 6. OEM of the offer products need to submit declaration on notarized 10 Rs. stamp paper that OEM compan y has not been blacklisted, debarred and Forbidden in any government, Semi government, PSU departments, Govt. Undertaking Departments and Urban Local bodies for any reason in last three years. If the declar ation given by OEM is found incomplete, wrong, manipulated or fake, then same offered bid will be cancelled, and appropriate action will be taken against the OEM
- 7. One year replacement warranty on OEM letter head with bid number and date mandatorily mentioned on it. need to be enclosed with bid documents.
- 8. Net Worth of the bidder should be in positive state. Net worth certificate provided from charted account ant need to be enclosed with bid documents.
- 9. OEM's Price list of offer product need to be enclosed with bid documents.
- 10. In case of partnership firm, Bidder need to attached partnership deed along with bid documents.
- 11. Bidder need to provide declaration on notarized 100 Rs. Stamp paper that no near and blood relative is working in NAGAR PALIKA PARISHAD BARAUT, UTTAR PRADESH.
- 12. Address Proof & ID. Proof of Individual/Partners/Directors along with Pan card and GST certificate of the firm need to be enclosed with bid documents.
- 13. Length of the Rope light will be 18 meter long with inbuilt Indian Flag Color lights, with length of each c olor will be 6 Meter Long.
