1. If the bidder wants to avail purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documents shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference on the basis of documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted (by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity. If contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer to the OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be as per line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

5. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organisation or PSU (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of having supplied some quantity during the last three Financial years. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

6. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA.

- If number of technically qualified bidders are only 2 or 3.
- If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
