1. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc.

This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

2. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

# **Standard Terms and Conditions of Tender**

# ATC.

1. The tender for materials/equipment/equipment etc. will be participated by the respective supplier on GeM portal. It will be mandatory for the authorized seller to submit the authorization letter of the form to the authorized dealer or agent while producing them.

2. The bidder will be given priority if the Gem User Expert Gold Certified Certificate with the tender.

**3.** CVC certificate/document of the tenderer has to be uploaded.

**4.** In the technical part, ensure to upload all the necessary documents (Techno Commercial Profile), PAN Car d, GST and certificates of the documents mentioned in serial no. 2-3. After opening of tender, no document s related to the tender will be accepted.

**5.** The Bidder Should be from same state.

**6.** If the tenderer does not upload any of the certificates/documents called for in the tender document, ATC and corrigendum, if any, his offer will be rejected.

**7.** Physical demonstration of all the materials, tools and equipment of the farm will be done and technical te sting will be done. After the physical demonstration, sample testing of the displayed materials/equipment/e quipment will be done as per requirement in all the items, detailed information in this regard will be given by Nagar Panchayat Hathua Gopalganj.

**8.** The Bidder participating in the tender must ensure that the CCTV hardware products are BIS, CE, certified

- **9.** OEM should have ISO 9001:2008 or latest certification for manufacturing all types of cameras.
- **10.** Under any circumstance, The Bidder will guarantee the material, equipment, etc. for a duration of not less than 3 years.
- **11.** OEMs should not be suspended/blacklisted on any open platform globally.
- **12.** All cameras, NVRs of the tenderer should be from the same OEM or fully compatible with VMS cameras fo r seamless integration and ease of operation.
- **13.** Tender priority will be given to the camera and NVR manufacturers, particularly to those OEMs that have been registered in India for a minimum of 15 years under the Companies Act. Tenderers supported by the necessary legal documents will be granted this preference.
- **14.** CCTV OEM should have direct service/support center in the any state for more than 7 years. Necessary S ales, Service Tax Registration Certificate will be provided along with the tender.
- **15.** The surveillance OEM should have its factory in India with Make in India facilities.
- **16.** The bidder will be given priority if the previous experience in the supply of equal products in any municip al body. Work order/PO should be uploaded.
- **17.** The suggested cameras and NVR's OEM will have provided at least 1000 cameras for a single and multisite project. It is necessary to confirm that the suggested OEM cameras are functioning effectively in the same project context. Tenderer that are accompanied by supporting documents will be prioritized.
- **18.** OEMs of CCTV equipment should provide self-declaration that they are not restricted, blacklisted by any government/institution across the world.
- **19.** The bidder himself will bear the expenses incurred in the supply of materials/ equipment/ installation of equipment.
- **20.** The supply of material/equipment/equipment will be done at the place decided by the competent authori ty. The supplied material/equipment/equipment will not be considered accepted until the concerned inspector declares the material/equipment acceptable after inspection. And on receiving the information about the accepted material/equipment, the tenderer will have to return the accepted material/equipment at his own expense. The said material and equipment will have to be taken back.

- **21.** The financial part of the forms declared successful will be opened on the basis of terms and conditions and specifications of the tender.
- **22.** A final contract (agreement) will be made on GeM portal along with the successful form. After mentionin g its terms and conditions, in case of non-supply of material, a decision will be taken to take action against the bidder as per rules and blacklist the wall.
- **23.** The Executive Officer, Hathua, Gopalganj reserves the right to cancel the tender at any time, without not ice, or to increase or decrease the quantity of the specified items as required. The number of cameras and their installation locations are subject to change as required.

# अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
- 16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.

17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
