- 1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
- 2. If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the the eligibility criteria of "Experience Criteria" as defined above subject to their meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
- 3. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 4. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
- 5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

- 6. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:
 - i. If number of technically qualified bidders are only 2 or 3.
 - ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
 - iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
 - iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
 - v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

1. Buyer Added Bid Specific ATC

Eligibility Criteria

- Ø The bidder must have their own shop in South Andaman region (any relevant documentary evidence must be submitted).
- Ø The bidder must possess a valid FSSAI licence/ registration certificate
 - Ø Bidding firms fulfilling the above criteria must mandatorily upload the following documents/certificates. Failure to do so will result in the rejection of the bid.
 - a. Shop registration certificate/document.
 - b. FSSAI (Form-C) A&N Administration Food Safety Standard Authority of India license/ registration certificate under FSSAI Act, 2006.
 - c. Self-attested copy of PAN card of the firm/proprietor/partner.
 - d. Self-attested copy of GST registration.
 - e. Experience certificate showing supply of items to Government Departments/Organizations/Publi
 - $c \ Undertakings/Autonomous \ Bodies/Companies \ for \ a \ minimum \ of \ three \ years.$
 - f. MSME certificate for exemption in experience.
 - g. Other documents, if any.

Terms & Conditions

- Ø The quality of items should be good/fresh and supply should be made by the bidder as per the requisition given by the storekeeper at main gate of District Jail, Prothrapur, Sri Vijaya Puram.
- Ø The bidder should carefully go through all the clauses and details indicated in the bid document before quot

ing the rates. No excuse that the conditions have not been read or understood will be entertained later. Ho wever, if the bidders have any doubt about any portion of the bid or require clarification on any of the aspect, they may contact the store section of the District Jail, Prothrapur, Sri VijayaPuram for clarification before submission of the bid.

- Ø The rate quoted by the firms for the items should be final inclusive of all taxes/ charges as applicable.
 - Ø Revision of rates will not be allowed after the opening of the bid.
- Ø The L1 shall be arrived at on the basis of the total amount quoted by the bidder in the bid and shall not be it em wise.
- Ø The successful bidder shall submit a Performance Guarantee @ 5% of the total contract value within two we eks (14 days) from the date of award of the contract. The Performance Guarantee must be submitted in an acceptable form, drawn in favour of the Drawing and Disbursing Officer, District Jail, Prothrapur, Sri VijayaPuram, from a commercial bank.
- Ø The ordered items shall be supplied in a staggered manner.
- Ø On receipt of information regarding supply, items have to be delivered within 10 days to the consignee.
- \emptyset Monthly requirement may vary from month to month and the monthly requirement will be informed to supplier by the consignee.
- Ø The items will be received by the Store keeper, District Prison, Prothrapur.
- Ø The validity period of the contract shall be 06 months from the date of award of contract. However, it may be extended for a further period of up to 02 months or till finalization of the new bid, whichever is earliest.
 - Ø No relaxation shall be allowed for delayed supply under any circumstances, exc ept under force majeure conditions such as natural calamities, strikes, or other unforeseen events beyond the control of the supplier.
- Ø It is the sole responsibility of the seller to deliver the items in good condition. If the items are found damage d the same should be replaced immediately with fresh items by the supplier without any additional cost.
 - Ø In case the suppliers fail to honour the commitment after acceptance of the contract this department will be liable to forfeited the performance security lying with us. More than one such default would also cause debarment & exclusion of such bidders and cease all transactions with the firm.
 - Ø The bid-inviting authority, at its discretion and depending on the actual needs of the department, re serves the right to increase or decrease the quantity by up to 25%, without any change in the ter ms and conditions or the prices quoted by the bidder. The department also reserves the right to pr ocure the full or partial quantity from the L1 bidder, stating the reason for doing so.
 - Ø If the seller fails to deliver any or all of the items within the original/ re-fixed delivery period(s) specified in the contract, the buyer will be entitled to deduct/ re cover the Liquidated Damages for the delay, unless covered under force majeure conditions, @0.5% of the contract value of delayed quantity per week or part of the week of delayed period as per-estimated damages not exceeding 10% of the contract value of delayed quantity without any controversy/ dispute of a ny sort whatsoever.
 - Ø The acceptance of the bid rests with the Superintendent, District Jail, Prothrapur, Sri Vijaya Puram, w ho is not bound to accept the lowest or any bid and reserves the right to reject any or all bids with out assigning any reason.
 - Ø The bidder shall not sub-let or assign the work to any other agency.
 - Ø Advance payment will not be made under any circumstances.
 - Ø The supplier shall submit the bills on the GeM portal in parts, upon completion o

f each respective month.

- \emptyset The supplier shall comply with all applicable state, local, and central laws, as well as statutory rules and regulations.
- Ø Arbitration and Jurisdiction:Both parties shall make every effort to resolve any disagreement or disp ute arising in connection with the agreement amicably. In case of failure, all disputes shall be refer red to a sole arbitrator appointed by the Hon'ble Lt. Governor, A&N Islands. The arbitration procee dings shall be conducted in accordance with the provisions of the Arbitration and Conciliation Act, 1996. The venue for arbitration shall be Sri Vijaya Puram, A&N Islands. If arbitration fails, disputes shall fall under the jurisdiction of the competent court at Sri Vijaya Puram, A&N Islands.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
