- 1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
- 2. If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking exemption from Turnover shall upload the supporting documents to prove his eligibility for exemption.
- 3. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. 4. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted. 5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

ADDITIONAL TERMS AND CONDITIONS

1. Basic Eligibility

The bidders must satisfy any of the following conditions to be considered as eligible bidder against the tender.

i)Indigenous Manufacturers: Indigenous manufacturers who manufacture the tend er item(s) are eligible to quote against the tender.

ii)Indian SellingAgent: Authorised Indian Selling Agents/Dealer/Distributor of indige nous manufacturer is also eligible to quote on behalf of its principal against the tende r, in case manufacturer as a matter of corporate policy does not quote directly. Howe ver, in such case, authorised Indian Agent shall have to upload scanned copy of tend er specific Manufacturer's Authorization, signed and stamped by the manufacturer to quote against the CIL Tender, indicating the GeM Bid No. and date along with the offe r.

In case an Indian Agent is participating in a tender on behalf of one manufacturer, it is not allowed to partic ipate / quote on behalf of another manufacturer in this tender or in a parallel tender for the same item. Furt her, in a tender, either manufacturer can quote or its authorised Indian Agent can quote but both are not all owed to participate/ quote in the same tender. Also one manufacturer can authorise only one agent to quot e in the same tender. All the bids, not quoted as per the above guidelines, will be rejected.

2. Provenness Criteria

The offered product shall be considered proven provided the tendered item(s)/simila r item or items of higher specification have been supplied during the last 5 years from the date of tender opening against orders of CIL and its subsidiaries, other PSUs, Government Departments and Private Organizations and their performance has been found satisfactory.

Note: The supplies must be completed at least twelve months prior to last date of tender s ubmission.

In case, the bidder submits copy of supply order(s) which have been placed against any Rate Contract, the bidder should submit copy of the Rate Contract against which such order(s) were placed.

The bidder should submit satisfactory performance certificate as per the provisions of the supply order for the quoted items from the end user, against supply order(s) s ubmitted against proveness criteria. Satisfactory performance certificate should indicate supply order details.

In case, the Performance Report(s) of the End-User(s) is not available for the supply orders submitted alo ng with the offer issued by CIL/it's subsidiaries/Govt. Departments/Government organizations/Private org anization, the bidder shall submit self-certification as per the format given as Annexure-B claiming satisfa ctory performance as per the provisions of the supply order against the Purchase Order(s)/ Rate Contract(s).

Relaxation of Norms for Startups and Micro & Small Enterprises (MSEs in Public Procurement R egarding provenness criteria)

a) If bidders have submitted documents to prove the Startup/MSE status for the tendered item without cert ificate towards quality, assurance and capability from some authority like MSME, NSIC, etc., the Tender Invi ting Authority, if needed, may assess the techno-commercial capability of the vendors to manufacture and deliver goods as per the prescribed quality and technical specification before awarding contract to them. Fo r this purpose, a 'Proforma for Equipment and Quality Control' (as per Annexure-C) has to be enclosed in the tender documents and such MSEs/ Startups should be asked to submit the details of plant & machinery, quality control arrangements, etc., in the above proforma along with their bids for verification of their technical capability. After opening of bids, the verification of technical capability may be done by the concerned T echnical Department immediately without any undue delayso that it is available for consideration at the ti

me of evaluation/ processing of offers.

- b) If required, a techno-commercial team of MCL may visit the manufacturing unit of the vendor.
- c) If favourable technical capability reports obtained earlier on such firms for supply of the item in question as per the required specification is available, these may be considered, provided date of such reports are n ot more than one year from the date of opening of bids.
- d) In case there is deficiency in technical capability of the firm, the same shall be communicated to them by tender inviting authority for improvement in the quality of their product for future tenders and clearly indicating that their offer cannot be considered for relaxation against the tender in question and to avoid any future complications. The issues relating to Technical capability shall be decided by Head of Technical Department.
- e) If bidders have submitted documents to prove the Startup/MSE status for the tendered item and their pr oducts are ISI marked/DGMS approved/Proven in CIL or its Subsidiary companies/Proven product of the anci llary unit of a Subsidiary Company of CIL, they will be required to submit the following applicable related do cuments, duly notarized, for relaxation from the criteria of prior experience and prior turnover: -
- Valid BIS/ISI Marking License for the quoted items on them.

Note: Bidders registered with MSE as manufacturers of goods are exempted from submission of EMD. MSE bidders registered for services and traders are not exempted from submission of EMD, their bid shall be rejected if they do not submit EMD. The technical acceptance of their bid is subject to the bidder having manufacturer of their quoted product clearly mentioned in the list of categories.

4. Security Deposit: (ePBG in BID):

The Security Deposit shall be for an amount of @5% of the total landed value of the contract including all t axes, duties and other costs and charges.

The Security Deposit shall be deposited through RTGS / NEFT / IMPS /other digital modes or in the form of a Bank Guarantee within 15 days from date of notification of award or placement of order.

The SD BG shall remain valid up to 02 months after completion of supplies and acceptance of material by t he consignee. In case of failure to supply the material within scheduled delivery period, the SD BG should be extended proportionately by the seller to cover the extended delivery period.

If the successful tenderer fails to deposit the security deposit within 15(fifteen) days from date of Notification of Award / placement of Order, another opportunity may be given to them for submission of Sec urityDeposit within next 15 days. If the successful tenderer still fails todeposit the security deposit within the extended period but executes the supplies within the extended security deposit submission period, thesu bmission of Security Deposit may be waived, as the purpose of submission of SD is fulfilled.

In cases where the successful tenderer did not submit the securitydeposit even within the extended period for SD submission but hassupplied the materials either in full or in part after the extended periodfor SD sub mission, a penalty equivalent to 0.5% (half percent) of SDamount for delay of each week or part thereof (pe riod of delay is to becalculated from the 31st day from the date of Notification of Award /placement of Orde r to the date of receipt of full SD/deduction of full SD)shall be levied subject to a maximum of 10% of the contract value.

7. Shortfall / Confirmatory Documents

After evaluation of the uploaded documents, shortfall/clarification documents, if applicable, shall be sought from the bidder. For this purpose, maximum 1 chance will be given.

The bidder needs to upload the requested documents within the specified period and no additional time will be allowed in this regard. If the bidder does not comply or responds by the specified time and date, his bid will be liable to be rejected.

The shortfall/information/documents will be sought only in case of historical documents which pre-existed a t the time of the tender opening and which have not undergone change since then.

The clarification/shortfall document submitted in the representation after technical evaluation in GeM port al will not be accepted. Only a representation about the wrong evaluation done will be considered. The clarification/representation submitted against the BID document through any mode other than GeM portal will not be considered.

- 8. The seller has to upload all relevant documents (like Guarantee/Warranty certificate, Delivery Challan, E -waybill, Test report, import documents, any other document mentioned in the contract/ Additional Terms a nd Conditions (ATC) document whichever is applicable) in the GeM portal while generating Invoice.
- **9. Inspection**: Final inspection of materials shall be carried out at the consignee's end by the authorized representative of SO(Safety)/Area, Orient Area at area level before acceptance of materials.
- **10. Price Fall Clause:** The price charged for the stores/equipments supplied against this tender by the bi dder shall in no event exceed the lowest price at which the bidder sell or offer to sell the stores of identical description to any organisation during the period of contract.

If the contract holder reduces its price or sells or even offers to sell the contracted goods or services following conditions of sale similar to those of the contract, at a price lower than the contract price, to any person or organization during the currency of the contract, the contract price will be automatically reduced with effect from that date for all the subsequent

supplies under the contract and the contract be amended accordingly. In case of parallel Rate / Running Co ntracts, if the price of a product is reduced for any supplier due to invocation of 'Price Fall clause' or any ot her reason, the same lower price shall also be applicable for the other suppliers who are having parallel RCs against the same tender. If any parallel RC holder does not accept the lower price, CIL shall have the ri ght to delete the item from the scope of RC of such firm and procure the same from other existing supplier / Reserve RC holders.

The provisions of price fall clause will however not apply to the following:

- i) Export/Deemed Export by the supplier;
- ii) Sale of goods or services as original equipment prices lower than the price charged for normal replace ment:
- iii) Sale of goods such as drugs, which have expiry date;
