2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Generic

Option Clause: Excess Settlement. The excess settlement has been enabled for the service, allowing

service providers to include additional charges up to a specified percentage of the item-level total value, including addons, in their invoices. Service providers must declare the applicability of additional charges during invoice creation and submit mandatory supporting documents to avail this option. The total invoice amount, including additional charges, shall not exceed the agreed-upon excess settlement percentage for the order.

3. **Service & Support**

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

4. **Service & Support**

5. **Payment**

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

6. **Past Project Experience**

Proof for Past Experience and Project Experience clause: For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. Contract copy along with Invoice(s) with self-certification by the bidder that service/supplies against the invoices have been executed.b. Execution certificate by client with contract value.c. Any other document in support of contract execution like Third Party Inspection release note, etc.**Proof for Past Experience and Project Experience clause:** For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. 7. **Purchase Preference (State)**

Bid reserved for MSE from the State of Bid Inviting Authority: Procurement under this bid is reserved for purchase from Micro and Small Enterprises from the State of Bid Inviting Authority having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal. If the bidder wants to avail themselves of the reservation benefit, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible to participate in this bid. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility based on documentary evidence submitted, while evaluating the bid. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

8. **Buyer Added Bid Specific ATC**

5.1 Bid Schedule

Opening and closing period: 10 days

5.2 Eligibility of Bidders

1. The bidder must be a registered legal entity in India with valid tax registrations.
2. Mandatory documents: PAN and GST registration certificates.

3. Geographical presence:

Must have a registered address in Chandigarh.

Proof via GST registration or EPFO/ESIC registration at Chandigarh.

4. Bids submitted under a Rent Deed will not be accepted.

5.3 Statutory Compliance and Affidavits

The bidder shall upload an undertaking or affidavit confirming non-default in EPF, ESI, and GST deposits for the last three financial years. A duly attested affidavit (by an Executive Magistrate) must declare: No bankruptcy, insolvency, or liquidation by any court/financial institution. No blacklisting by any Government body, PSU, University, or Court. No criminal, civil, or legal proceedings pending or registered. Acceptance of all tender terms and conditions. Undertaking: Eligible similar works have not been executed through another contractor on a back-to-back basis. Violation will lead to debarment and forfeiture of EMD/Performance Guarantee.

5.4 Experience and Financial Criteria

1. Minimum 3 years of experience in providing manpower services.

2. Submit a CA/Auditor's certificate showing average annual turnover for FY 2022-23, 2023-24, and 2024-25.

3. Must possess a valid ISO Certification.

4. Submit a Labour Department Registration Certificate (Form-F) issued by the Labour Department, Chandigarh.

5.5 Duration and Extension of Contract

1. Duration as specified in the bid document.

2. May be extended up to one (1) year based on satisfactory performance and mutual consent.

5.6 Payment and Wage Disbursement

1. Wages must be paid as per DC rates fixed by Chandigarh Administration.

2. Payment must be supported with EPF, ESI, and GST challans.

3. Bank statement showing salary disbursement must be submitted by the 7th of each month.

4. Bills shall be raised only after submission of proof of wage and statutory payments.

5. All penalties for delay in statutory payments shall be borne by the contractor.

6. TDS deductions under the Income Tax Act and GST Act will apply.

7. The Service Provider must maintain funds sufficient to cover at least three months' salary of deployed staff independently of pending payments from the department.

5.7 Deployment of Existing Resources

1. Existing manpower under the current contract shall continue, subject to their willingness.

2. Staff replacement requires prior written consent from the Buyer/Department.

5.8 Variation in Quantity

1. The purchaser reserves the right to increase or decrease manpower up to 25% during the contract period.

2. The bidder must accept such variations on the same terms and conditions.

5.9 Employee Documentation and Identification

1. Minimum qualification for outsourced manpower: Middle School (as per original joining date).

2. Service Provider must furnish:

Educational certificates, Aadhaar card, PAN card, Other relevant documents at deployment time

3. ID cards shall be issued by the Service Provider at their own cost (no reimbursement allowed).

5.10 Blacklisting and Penalties

1. The purchaser may blacklist the firm for up to three (3) years in case of any default or breach.

2. A reasonable opportunity of hearing will be provided before any blacklisting order.

5.11 Precedence of Conditions

In case of conflict between GeM portal terms and these Additional Terms & Conditions (ATC), the ATC shall prevail.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of

Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
