1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

- **2.6.1.1 Work Experience :** The bidder should have satisfactorily completed* in the last three previous fi nancial years and the current financial year upto the date of opening of the tender, one similar single servi ce contract** for a minimum of 35% of advertised value of the bid.
- *Completed service contract includes on-going service contract subject to payment of bills amounting to a t least 35% of the advertised value of the bid.
- ** Similar single service contract means : "Any transportation work / hiring of vehicle / Truck / MUV /Any Civil Engg. work / Track work on any Central Govt. / State Govt. / PSU unit."

Work experience certificate from private individuals shall not be accepted. Certificate from public listed co mpany/private company/trusts having annual turnover of Rs 500 crores and above subject to the same bei ng issue d from their head office by a person of the company duly inclosing his authorization by the manag ement for issuing such credentials.

Notes: The bidder shall submit details of work executed by them in the prescribed format along with bid f or the service contracts to be considered for qualification of work experience criteria clearly indicating the nature/scope of contract, actual completion cost and actual date of completion for such contract.

- **2.6.1.2 Financial Standing :** The Bidders will be qualified only if they have minimum financial capabilities as below
- (i) T1- Financial Turnover: The bidder should have an aggregate financial turnover not less than 1.5 ti mes the advertised Bid value during the last three previous financial years and in the current financial year upto the date of opening of the tender. The audited balance sheet reflecting financial turnover certified by Chartered accountant with her stamp, signature and membership number shall be considered.
- (ii) T2-Liquidity: The bidder should have access to or has available liquid assets, lines of credit and othe r financial means to meet cash flow that is valued at 5% of the estimated bid value net of applicant's com mitment s for other contracts. The audited balance sheet and/or banking reference certified by chartered accountant with her stamp, signature and membership number shall be submitted by the bidder along wit h bid. Banking reference should contain in clear terms the amount that bank will be in a position to lend for this work to the applicant/member of the Joint Venture/Consortium. In case the Net Current Assets (as se en from the Balance Sheets) are negative, only the Banking references will be considered. Otherwise the a ggregate of the Net Current Assets and submitted Banking references will be considered for working out the Liquidity.

The banking reference should be from a Scheduled Bank in India and it should not be more than 3 months old a s on date of submission of bids.

- 2. Joint Venture (JV) Firms are not eligible for this tender/Bid. (Authority: Railway Board's Letter No. 2002/C E/-I/37 JV Pt. VII I Dated14.12.2012).
- 3. Conditional offer will not be accepted and will be summarily rejected.
- 4. Wherever clause of GEM is silent for any modification / alteration, termination, then clause of GCC IR 20 18 or latest for services will be applicable.
- 5. If any dispute / contradiction arises between condition of GEM and Scope or work / Special condition upl oaded then condition of Scope of work / Special condition will be applicable.

- 6. Additional documents submitted by bidders and any modification / alteration / addition / deletion in their re-presentation will not be accepted.
- 7.Bidders are advised to read all the terms & conditions of bid and documents uploaded along with bid.
- 8. All other conditions will remain as per Special condition attached under the bid.
- 9. The bidders are required to submit an undertaking (Annexure-XVIII) certifying the truthfulness of all the documents submitted/uploaded along with the tender. This is mandatory for all the bidders. In case of failu re of the bidder to submit the undertaking, their offer will be summarily rejected.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
- 16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
