2. 7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

To Avoid unreasonably low service charges and subsequent exploitation of contract workers service charges quoted by the bidder must not be less than 3.85% (three dot Eight Five Percent), taking into consideration the applicable GeM Transaction charges and prevailing TDS rates as per Income Tax and GST Rules. Bidders quoting Service Charges less than 3.85% (Three dot Eight Five Percent) will be rejected during Commercial valuation.

4. The seller has to pay salary/wages of contracted staff deployed at buyer location on monthly bases Even in the event of delay in payment by CDA.

5. Post conclusion of the contract, the service provider shall ensure retention of the same manpower deployed under the previous contract. Any replacement, if necessitated due to unwillingness, unavailability or unsuitability of personnel, shall be made only with prior written approval of the buyer and the substitute provided shall possess equal or higher qualifications, experience and competence so as to ensure continuity of services without disruption

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-
