	The category has been created in accordance with the Model Technical Specification issued by the Ministry of Electronics and Information Technology (MeitY) vide letter no. W-43/4/2020-IPHW dated 19th August 2024, and is based on the parameters defined therein. The specifications applicable to this category are as per the MeitY Model Technical Specification dated 19th August 2024. Accordingly, buyers shall not specify or mandate any particular processor, processor brand, or manufacturer in the Additional Terms and Conditions (ATC). The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery

time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

## 2. DELIVERY & INSTALLATION:

- a. The successful bidder should deliver the laptops to the consignee location at their own cost within the deadline as per contract order. The delivery and installation should be executed during the working hours of Sub Regional Office-
- b. The bidder must submit declaration with respect to compliance of all T & C, ATC with specifications mentioned in the bid.
- c. Payment shall be released only after submission of the installation report with respect to all the Authorized Officer / official of Consignee Locations, proof for registration of warranty period of 05 years on OEM Website by the seller.
- d. After the delivery is made, if it is discovered that the items supplied are not according to specification prescribed in the tender, such supply would be rejected at the supplier's cost.

## 3. TECHNICAL SPECIFICATION

## 4. DEMONSTRATION AND TESTING BEFORE DELIVERY:

- a. At any stages during bidding process, the bidders are bind to make presentation/demonstration of the working of the product quoted before the competent authority, if required. Failure to demonstrate may lead to rejection of the bid.
- b. The competent authority has the right to demand for acceptance testing before delivery. The cost related to the acceptance testing shall be borne by the bidder. Failure to comply with acceptance testing may lead to rejection of the bid.



## 5. WARRANTY & MAINTENANCE:

- a. Minimum 5 years OEM comprehensive warranty support including all parts with onsite support. The device should not be declared end of life by OEM at the time of purchase. A declaration in this regard should be given by the bidder.
- b. OEM/Bidder should provide warranty support for the product supplied by them within 24 Hrs resolutions SLA.
