- 1. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
- 2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. - 3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

Eligibility and Qualification Criteria for Transportation Services

1. Turnover Certificate:

The bidder must have a minimum average annual financial turnover of ₹10 Lakh during the la st three financial years — 2022-23, 2023-24, and 2024-25.Documentary proof in the form of cer tified audited balance sheets or a certificate from a Chartered Accountant/Cost Accountant indicating turnover details for the said period must be uploaded with the bid.

Non-submission of the same shall lead to rejection of the offer.

2. Past Experience:

The bidder must have successfully executed at least one contract (in whole or in part) for provi ding transport services to Indian Railways, Central Government, State Government, or an y Public Sector Undertaking during the last three financial years including 2025-26. The completed value of a single contract should be at least ₹10 Lakh as on the date of bid op

3. **Geographical Presence:**

The bidder must have a **registered office anywhere in India** on or before the bid opening date. Acceptable documentary proofs include:

- MSE Certificates (UDYAM, Udyog Aadhaar, NSIC)
- ISO Certificate
- EPF/ESI Registration Certificate
- Telephone Bill (any of last 3 months)
- Electricity Bill (any of last 3 months)
 Failure to submit documentary proof shall result in rejection of the offer.

4. Earnest Money Deposit (EMD):

Bidders claiming EMD exemption as per GeM GTC must upload valid supporting documents. Bidders not eligible for EMD exemption must deposit the applicable EMD amount, failing which their offer will be summarily rejected.

5. Service Scope Compliance:

The service shall be executed strictly as per the Scope of Work specified in the bid docume nt only.

Tender Terms and Conditions for Transportation n Services

1. Bid Compliance:

Bidders must thoroughly read the bid document and all attachments before participation. All require d documents should be uploaded under appropriate headers on GeM (e.g., experience under "Experience", financials under "Bidder Turnover"). Incorrect or misplaced uploads may lead to rejection. The buyer will not be responsible for such omissions.

2. Scope of Work:

The service provider must supply vehicles meeting the specified scope and requirements.

3. Vehicle Requirements:

Vehicles (9T, or as required) must be roadworthy and less than **15 years old**, with valid **PUC** and **in surance**. Newly procured vehicles should have speed governors. Vehicles must carry materials with valid documentation, to be collected at loading and handed over at unloading points.

4. Driver Requirements:

Drivers entering the **Loco Workshop, Southern Railway, Perambur - 600023** must hold a valid license for the specific vehicle type, complying with all **RTA norms**.

5. Safety & Legal Compliance:

The contractor shall indemnify the Railways against any accident, loss, or damage during transit. Fo r critical consignments, a Railway escort may be deputed and shall be allowed to travel **free of cos** t.

6. Delays & Penalties:

7. Price & Payment Terms:

The quoted and accepted rate shall remain firm throughout the contract period. No price variation will be entertained.

8. Contract Termination:

The Railways reserve the right to **foreclose the contract** for administrative reasons with **two mon ths' prior notice**.

9. Credential Verification:

If any submitted document is found **false or forged**, the contract will be terminated, **EMD/SD/e-P BG forfeited**, and **legal action** initiated as deemed appropriate.

- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.

- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
