If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
- 2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. - 3. - 4. If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking exemption from Turnover shall upload the supporting documents to prove his eligibility for exemption.
- 5. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
- 6. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.
- 7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 8. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
- 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
- 2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
- 3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

- iv. All the cylinders should be filled properly in adequate quantity.

2. Service Level Agreement

- The vendor must refill the fire extinguishers to keep them in good working condition for regular u se.
- ii. The vendor must use only certified refilling materials and components.
- iii. Work completion timeline: 30 days from the issue of the purchase order.

3. Payment Terms

- i. STPI shall make payments to the Supplier after 100% completion of refilling of fire extinguish ers against submission of GST invoice subject to meeting SLA and LD Clause.
- ii. The vendor shall provide GST credit note for the penalty amount.

4. Penalty Clause:

i. STPI will charge the Liquidity Damage @ 0.2% of the contract value for delay of each day after the work completion timeline as per the SLA to the maximum 5% of the contract value.

5. Termination By Default

If the work will not be completed within the 25 days from the work completion timeline as per SLA, it will be considered a breach of contract, and STPI reserves the right to terminate the contract immediately. STPI shall not be liable to make any payment to the service provider and in this regard the decision of Director, STPI Mohali shall be final and binding on all parties.

6. General Terms:

- I. It will be the sole liability of vendor to pay for any kind of loss to STPI property or else if any unforese en accident occurs during refilling.
- II. Any repair work is required for fire extinguishers all spare parts shall be new and of good quality.
- III. The quoted amount should be complete and final. STPI shall not make any payment beyond the contr act amount.
- IV. The successful bidder shall be responsible for Test worthiness of the above mentioned refilled Fire Ext inguishers for a period of 1 years. The validity period of 1 years of the Fire Extinguishers should be affixed in the form of Tag on Fire Extinguishers.
- V. Bidders must submit the Letter of Acceptance for the Terms and Conditions for Refilling of Fire Exting uishers at STPI Amritsar as per Annexure 1

7. Site Visit:

All bidders are advised to physically visit (at their own cost) the site and familiarize themselves with the exiting setup of Fire Extinguisher system before submission of bid. Any bidder submitting the bid shall be considered to have full knowledge of the existing setup and any charges or issues raised on later stage by bid der shall not be entertained by STPI Amritsar.

8. Arbitration

In case of any dispute arising out of or in connection with the contract or in connection with the contract or the carrying out of the work, (whether during the progress of the work or after its completion) the matter shall be referred to Sole Arbitrator the Director, STPI, Mohali. The arbitrator's decision in the matter shall be final and binding on both the parties.
