Sole selling agent /authorized dealer / distributor will submit specific authorization from manufacturer to quote against the Tender (incorporating Tender no in authorization Letter) along with the copy of Registration certificate of their principal as a proof of manufacturer as stated above in point no B.
- D. Sole selling agent / Authorized dealer/distributor participating in the Tender on behalf of one manufacturer will not be allowed to quote on behalf of another manufacturer along with first manufacturer.
- E. Bidder should be manufacturer or authorized dealer of manufacturer. Authorized dealer should submit specific authorization for the particular Tender at the time of Bidding. Proof of manufacturer of Tendered item by manufacturer/principal should also be submitted at the time of Bidding .
- F. In case any Tenderer divert the Tender and opts to submit its offer through their authorized entity, then authorization letter(self attested and notarized in original) for specific Tender should be submitted along with their offer by the Firm quoting on their behalf. In an authorization letter Tender no must be incorporated. The copy of registration certificate of their principal as proof of manufacturer as stated in point (B) should be submitted.
- G. The above Bidders who have supplied Tendered/Similar item/s or Tendered/Similar item/s of higher specification during last 5 years and successfully executed the purchase order/orders in the past to any Govt./Semi Govt./PSU/CIL or its subsidiaries companies or Private Organizations shall be eligible.
- H. The Bidder must enclose proof of past supply i.e. copy of firm supply order for Tendered/Similar item/s or Tendered/Similar items of higher specification from any Govt./Semi-Govt./PSU/CIL or its subsidiaries companies or Private Organizations in support. Copy of Invoice /dispatch challans against the proof of supply order to be submitted.
