Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchas preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Buyer Added Bid Specific ATC

TERMS & CONDITIONS

1. **Eligibility Criteria**: The bidder/OEM should meet the following minimum p e-qualification eligibility criteria

Agencies not meeting the eligibility criteria shall be summarily rejected:

- i. Tenderer should be the manufacturer / authorized dealer. Letter of Authorized (as per FORM A) from original equipment manufacturer (OEM) specific to the tender should be enclosed.
- ii. The tenderers must be in existence in supplying of the furniture to any IT's / NIT's / IISER's / Central Universities / other Central Govt. (rganizations at least for any 3 years (Not consecutive years) before he bid opening date. The requisite supporting certificate (copy of purch ase order/work order) shall be required in addition to Turnover certificate as per FORM C.
- iii. Experience should be in the name of the tendering firm/company and rot in subsidiary as associate firm/company/group of firm/companies, ard not of OEM. Experience of having successfully completed works at Certral Government Department/State Government Department /Central Auonomous Body/Central Public Sector undertaking/State Autonomous Body/State Public Sector undertaking for any 3 years (Not consecutive year) before the bid opening date. Completion Certificate as given above f similar nature should be provided. Similar work means: Manufacturing, supply & installation of furniture. Documentary evidence is required to be produced and details shall be listed (as per FORM-B).
- iv. Bidder must submit Declaration of Local Content as per Form D
- v. Bidder must submit Declaration of Non-blacklisting as per Form E
- vi. Certificate of Land border sharing related declaration must be submitted as per **FORM F**
- vii. Joint venture (JV)/ Consortium are not permitted.
- viii. Manufacturing Facilities: The OEM should have own manufacturing/fak

rication, machinery & infrastructure facilities. The agency should possess valid license for establishment of manufacturing facilities from respective authorities (Furnish the copy of documentary evidence such as MSME ce tificate)

- ix. In House testing facility: Manufacturer should have preferably in house esting facility for furniture (furnish copy of documentary evidence),
- x. Certifications: Manufacturer should be member of BIFMA (Furnish copy of the valid certificate)
- xi. Bidder/OEM must be submit ISO 9001: 2015, ISO 14001:2015, ISO 45001:20 8 issued by NABCB/Quality Council of India, Ministry of Commerce, GOI
- xii. Bidder/OEM should have a valid AIOTA certificate. Certificate should be attached with other documents while submission of bid.
- xiii. The quoted products should have product specific Green pro certificate issued by CII <u>/Green Guard certificate issued by UL</u> to be attached during submission of bids.
- 2. **Delivery of furniture**: Delivery of the goods should be made within a maximum of 60 days from the date of placement of purchase order.
- 3. **Progress of Supply**: Wherever applicable, supplier shall regularly intimate progress of supply, in writing, to the Purchaser as under:
- (i) Quantity dispatched/delivered to consignees and date;
- (ii) Quantity where incidental services have been satisfactorily completed with date:
- (iii) Quantity where rectification/repair/replacement effected/completed on releipt of any

Communication from consignee/Purchaser with date.

(iv) Date of completion of entire Contract including incidental services, if any; and

- (v) Date of receipt of entire payments under the Contract (In case of stage-v ise inspection, details required may also be specified).
- 4. **Installation**: The supplier is required to do the installation and demonstration of the Furniture supplied within three weeks of the arrival of materials at the IIT Jammu, site of installation, otherwise the penalty clause will be the san e as per the supply of materials. In case of any damage to item and supplies during the carriage of supplies from the origin to the installation site, the supplier has to replace it with new items immediately at his own risk. IIT Jammu will not be liable to any type of losses in any form.
- 5. Warranty: Warranty period shall be three (03) years from the date of the nstallation and acceptance of Goods at IIT Jammu. The Supplier shall, in addit on, comply with the performance and/or consumption guarantees specified ui der the contract. If for reasons attributable to the Supplier, these guarantees a re not attained in whole or in part, the Supplier shall at its discretion make su ch changes, modifications, and/or additions to the Goods or any part thereof a s may be necessary in order to attain the contractual guarantees specified in the Contract at its own cost and expense and to carry out further performance e tests. The warranty should be comprehensive on site. The Purchaser shall p omptly notify the Supplier in writing of any claims arising under this warranty Upon receipt of such notice, the Supplier shall arrange to repair or replace the defective goods or parts within 3 days free of cost in IIT Jammu. The Supplier shall take over the replaced parts/goods at the time of their replacement. No claim whatsoever shall lie on the Purchaser for the replaced parts/goods there after. The period for correction of defects in the warranty period is 03 days.
