as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. ### 1. Generic

**OPTION CLAUSE:** The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

### 2. Scope of Supply

Successful Bidder has to upload scanned copy of the FDR document in place of PBG and has to ensure delivery of hard copy of Original FDR to the Buyer within 15 days of award of contract.

#### 8. Buyer Added Bid Specific ATC

**The below mentioned terms and conditions stipulated AT C will supersede those in GTC (as above), in case of any conflicting provisions:**

##### **(A) Eligibility criteria:**

##### **(1) Past performance:**

Past Performance mentioned in the bid to be read as below;

(a) The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same Category Products ( i.e Towel as per IS 854) for minimum of 30% of bid quantity, cumulatively of the any three Financial years of the last five financial years before the bid opening date and current financial year upto the date of opening of bid, to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity.) to be submitted along with bid in support of quantity supplied.

(b) For past performance firm should attach proof of supply signed by either purchaser, consignee. For this purpose receipt note, CRAC, receipted challan, work completion certificate etc should be attach. Proof of supply should clearly indicate quantity supplied and date of supply. Only copy of PO, self-signed tax invoice, self-made performance statement does not establishes that supply has been completed.

##### **(2) Handloom Mark/Handloom origin certificate:**

**All supplies should have Handloom Mark.**

**The purchase is restricted from the sources/suppliers/bidders having valid handloom origin certificate. The bidder shall submit handloom origin certificate along with bid and at the time of supply.**

##### **(3) Manufacturer Authorization:**

(a) Wherever Authorized Distributors/Trader/Agent are submitting the bid, Authorisation Form /Certificate with OEM, bid specific authorization such as details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid.

(b) Trader/Distributor/Agent participating on behalf of OEM are not entitled for benefit of MSE such exemption of Earnest Money Deposit and security deposit. Even though the OEM is eligible for exemption of Earnest Money Deposit and security deposit.

Trader/Distributor/Agent participating on behalf of OEM to remit the applicable EMD and SD wherever required.

##### **(4) Advance Sample Approval:**

(a) Firm should submit 07 advance samples, within 07 days from date of contract, before bulk supply to one of the consignee i.e Sr.Divisional Material Manager/Jodhpur/NWR for approval for feel, finish, shade& work



kmanship only and consignee should approve the samples within 07 days from date of samples received from supplier. The supply should be in conformity with the sample in such respects only. Whereas for the remaining characteristics the supplies must be in conformity with the PO descriptions and specifications.

(b) If there is delay from buyer side in approval of advance sample – the delivery period shall be refixed without LD for the period of delay in sample approval. In case, the sample is found to have major deviations / not conforming to the Contract specifications, the buyer at its discretion may call for fresh samples for approval before allowing bulk supplies or may terminate the contract after notifying the deviations to the seller. All samples required for test shall be supplied by the contractor free of cost. Any expenses incurred by the contractor on or in connection with the production of stores in bulk, before the sample has been approved unconditionally shall be borne by the Seller and he shall not claim any compensation in the event of such sample being found unacceptable by the Buyer / Consignee.

(c) 1 no of sample shall be send to firm to guide manufacture, 1 no of for Inspecting authority to guide inspection and 1 no to be kept with consignee (Sr DMM/Jodhpur to send the 1 nos of approved sample to each consignee) to compare with bulk supply (All samples shall be duly sealed & signed by the consignee)

(d) Sample approved once shall be applicable to all lots including supply against option clause, if any.

**(5)** Firm must attach following documents along with any other document(s) required against this bid

(a) Documents in support of MSE registration (If applicable).

(b) Documents in support of Make in India policy i.e. % of local content in the offered product for purchase preference.

**(6) Inspection clause:** Inspection by RITES at manufacturer/manufacturing premises (Charges to be borne by seller). offers/bids with any deviation towards inspection clause summarily rejected.

**(7)** The bidders is required to upload, along with the bid, all relevant certificates and other certificates as prescribed in the product specification given in the bid documents.

**(8)** E-PBG has been asked towards security deposit and the IREPS Purchase order will be issued after receipt of security deposit only. Security deposit can be submitted in any form as eligible in GeM.

Also the firm to submit certification from the bank issuing the bank guarantee that sufficient value of stamp duty paid by the bank according to the stamp act of the concerned State.

**(9)** Firm to submit valid IREPS ID along with offer to issue IREPS coverage PO in case GeM order is placed.

**(10) Warranty Period:**

Warranty period will be "12 month from the date of supply of material at consignee end or one year from the date of putting material in to service, whichever is earlier."

**(11) Packing:**

**(13) In case of technical clarification:**

During evaluation and comparison of bids, the purchaser *may, at his discretion*, ask the bidder for clarifications on the bid.

- The request for clarification shall be given asking the tenderer to respond by a specified date. If the tenderer does not comply or respond by the date, his tender will be liable to be rejected.
- Depending on the outcome, such tenders are to be ignored or considered further. No change in prices or substance of the bid shall be sought, offered or permitted.
- No post bid clarification at the initiative of the bidder shall be entertained.
- The shortfall information /documents shall be submitted only in case of historical documents, which pre-existed at the time of the tender opening and which have *not undergone change*, since then. So far as the submission of documents is concerned with regard to qualification criteria, after submission of the tender, only *related shortfall documents* shall be submitted for. For example, if the bidder has submitted a supply order without its completion / performance certificate, the certificate can be asked for and considered. *However, no new supply order should be asked for so as to qualify the bidder.*

- (14)** Bidders are advised to go through the clause 29 i.e clause of title “One **Bid per Bidder**” of GeM GTC and quote accordingly. By making a bid pursuant to the Tender Documents, the bidder / tenderer shall be deemed to have declared that the bidder / tenderer has not made any other bid or multiple bids as understood or deemed in terms of this clause.

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.

7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

**All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.**
