

7. Eligibility for Participation:

NTPC enlisted vendors for the Contract Enlistment Group (CEG No: AST-01, Nam e: "TRANSPORTATION OF ASH THROUGH ROAD FROM NTPC") with Average Ann ual Turn Over (AATO) & EC (Execution Capability) both equal to or more than

Rs. 30,40,20,000/- can only participate in this tender. Others shall not be conside red. Applications by vendors not meeting these criteria shall be rejected during technical evaluation.

If non enlisted/rejected vendors are interested to participate, can do so in futur e tenders first by enlisting themselves for the respective product category (CEG). They shall have to visit NTPC CPC website www.vendor.ntpc.co.in and submit online application against items/services (Material /Contract Enlistment Groups) of their choice. If they meet the criteria stipulated in the Qualifying Requirement, they shall be enlisted in line with the Terms and Conditions of enlistment.

All participating vendors in this tender shall submit their enlistment ce rtificate issued to them with mention of AATO & EC values for the item category (CEG) or submit any other proof of their enlistment in which AATO & EC along with CEG is mentioned.

- 8. "The format of the Bank Guarantee shall be in accordance with the form of Bank Guarantee towards Bid Security/EMD/Performance security included in the Employer's Bidding Documents only (refer Section-VIII: Forms and Procedures (Book 3 of 3)). - 11. EMD exemption: Micro and Small Enterprises (MSEs) having UDYAM Registration, for goods produced a nd services rendered, shall be exempted from paying Earnest Money Deposit. Such registered bidders will have to submit UDYAM Registration Certificate, as a proof of being MSE on GeM Portal.
- 12. To avail MSE benefit in respect of EMD exemption and purchase preference, Bidder should be a manuf acturer of offered product. Traders are excluded from purview of MSE benefit.

14. Instructions for filling the Price Bid:

- (4) Bidders are requested to must check the total package cost against the esti mated cost of NIT before submission of GEM Bid online to avoid any confusion la ter. After opening of technical Bids, Bidders are not allowed to modify/change the rates/amount whatsoever.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.

- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.

- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
