(a) This is to certify that the Hardware and the Software being offered, as part of the contract, does not contain Embedded Malicious code that would activate procedures to :-

- (i) Inhibit the desires and designed function of the equipment.

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

#### 20. Rate Contract

ISO 9001: The bidder or the OEM of the offered products must have ISO 9001 certification.

#### 21. Rate Contract

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any

Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the year.
