1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within  $L-1+ 15\%$  (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents

submitted.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

#### 1. Scope of Supply

Scope of supply (Bid price to include all cost components) : Only supply of Goods

#### 2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. Preferably manufacturers should participate. Participating traders/agents must provide authorization letter issued by the OEM. Authorization letter should be bid specific. Bidders must submit authorization letter along with their offer failing which the offer will be summarily rejected.

2. General damages If the Contractor fails to deliver the goods or any instalment thereof within the period fixed for such delivery in the contract or as extended or at any time repudiates the contract before the expiry of such period the Purchaser may without prejudice to his other rights-

(a) Without prejudice to the Purchaser right to record adverse performance of the contract or for taking appropriate administrative action, cancel the contract or a portion thereof and forfeit the security deposit.

(b) Wherever Security deposit has been exempted for any reason, levy damages from the supplier, not by way of penalty, an amount equal to Security Deposit amount, as would have been applicable had he not been an exempted vendor. These damages shall be treated as recoveries outstanding against the Contractor and dealt with accordingly.

3. Bidder is mandated to submit Annexure I attached in this bid.

4. Warranty Period shall be minimum 1 year, specifications mentioned above or as per OEM's specification whichever is higher. Tender/Bid specific warranty period certificate confirmed by the OEM on its letterhead to be submitted by traders along with the offer failing which Railways reserves the right to disqualify the offer. OEM warranty certificates must also be submitted at the time of delivery of Goods.

5. In addition to the technical specifications as per GeM category specifications outlined in the bid document, this bid includes additional requirements as detailed in the buyer added bid specific documents. Bidders are required to review these specifications carefully and provide compliance remarks for each parameter. Failure to provide compliance remarks will result in disqualification of the offer during the evaluation process.



ss. In case of any discrepancy between technical specifications as per GeM category specifications and additional requirements as detailed in the buyer added bid specific documents, the later one will prevail.

6. Railway reserves the right to ignore offer of any such bidder who has faced cancellation/termination of contract with imposition of penalty/incident on account of unsatisfactory performance/execution of contract of any equivalent services/goods during the past 12 months. This period of 12 months shall be counted with respect to date of tender closing.

7. Delivery of goods in required number of delivery instalments [as specified in the bid document] is mandatory. This is a mandatory requirement and no deviations to this will be permitted or considered while consideration of the offer. Bidders, if not willing to supply in required number of delivery instalments, must not submit the offer. Bids if submitted for any consignee shall be considered as deemed acceptance of delivery of goods in required number of delivery instalments [as specified in the bid document]. The purchaser however, in case of any urgency, reserves the right to amend the delivery period with prior intimation to contractor. Any deviation regarding no. of delivery instalments or remarks for not agreeing to this condition, offered in the deviation column or anywhere including in uploaded document will not be accepted or considered while consideration of the offer. The purchaser may, at his discretion ignore any such deviation, if quoted, while issuing the contract. No further claim by the bidder shall be admissible in such cases.

8. In case of non-submission of requisite credentials. The offer will be rejected and no representation or claim will be entertained in this regard.

9. Railway reserves the right to validate authenticity of any document submitted by the bidder from its issuing authority. Contact details [Name/Designation/Official email/Mobile no.] of the issuing authority must be provided by the bidder if asked for, failing which Railways reserves the right to disqualify the offer.

15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
