#### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

#### 2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1) The contractor shall provide one non-AC vehicle (GEM Vehicle Type: Service Type, 1500 km monthly) fo r outstation use for 12 Hrs daily for a period of 24 months for ADSTE/S1/BB. The contractor shall bear all ex penses, including vehicle, driver, cleaner, fuel, oil, lubricants, accessories, major and minor repairs, permit s, maintenance, taxes, and other associated costs. The vehicle shall be subject to inspection by the consig nee. ADSTE/S1/BB shall maintain and sign logbook.
- 2)The hired vehicle shall be parked at the residence or office of ADSTE/S1/BB, or at any other location as d irected by the consignee officer.

- 4) The vehicle shall be operated as per the consent and convenience of the consignee officer.

5)The vehicle hiring shall strictly adhere to the new vehicle hiring policy issued by Central Railways GM Off ice vide letter no. G.452/Hiring/Policy 2024 dated January 11, 2024. Document attached in Clause 10. **Buy er Added Bid Specific ATC.**Bidders must submit a declaration confirming compliance with this clause.

6)The vehicle is designated for outstation use and may be required to operate from any location to any ot her within the jurisdiction of Central Railways.

7)The bidding firm must have a registered office in Mumbai/Mumbai suburban/Navi Mumbai.

8)1. The officer's vehicle will be stationed at Mazgaon Railway colony/CSMT; therefore, drivers must resid e in close proximity. The bidding firm must have a registered office in Mumbai/Mumbai suburban/Navi Mumbai.

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

#### 5. Payment

**PAYMENT OF SALARIES AND WAGES:** Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.

- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.

- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
- 16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
