In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 4. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the OM_No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.
- 5. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.
- 6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 7. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting

bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

1. Experience Criteria:

Past experience: Firm should have past experience on comprehensive maintenance a nd/or overhauling of Sewage Treatment Plant/ Water Treatment Plant/ Water recirculation system 30% of the estimated cost within last five(05) years from the date of Bid Opening in Ordnance Fys/Other Govt. Organization/PSU/Govt. undertaking/Priv ate sector company. As credential work completion certificate along with work order both to be furnished. If required capacity verification based on the data furnished by the firm in the technical bid may be undertaken if considered necessary by the comp etent authority at MSF.

It is mandatory for all bidders to submit the past experience certificate, there will be no exemption/relaxation MSE and start ups.

- 2. Payment Terms: 100% Payment should be made after completion of work and successful job completion certificate(JCC) and acceptance certificate issued by u ser section. Signed copy of Payment GST, Tax invoice, contractor bill(each two c opies) should be attached with the bills for payment.
- **3.**Buyer Added Terms and Condition i.e. ATC will supersede the clauses of GEM GTC
- **4.EMD** 2%(Rs.17,700.00) of the estimated cost however exemption is applicable in submission of Micro & Small Enterprises having Udyam Registration Certificate Number issued by department of Micro, Small & Medium Enterprises (MSME) or firms regd. with Ordnance Factories/the Central Purc hase Organization /the concerned ministry / Department / startup as recognized by Dept. of Industrial Policy & Promotion (DIPP) or Central PSUs.
- **5.**For delay completion the work L.D. shall be charged @ .5% S.O. value per w eek and part thereof In case of unsatisfactory service, the penalty up to the ext end beyound the 10% of the contractual value will be recovered from the contractor as decided by the competent authority and beyound which contract is liab le to be terminated. Executive Director MSF reserves the righ to cancel/short clo se the contract as and when required and for that No complensation will given to the firm.
- **7.Special Note:** For execution of the work, all the requisite equipment mentioned in the Scope of work (Point No. 1) should be provided by the contractor. Requisite consumable materials mentione d in Scope of Work (Point -1) should be provided by the contractor.
- **8. Guarantee Period:** The contractor shall agree for adherence to guarantee period for satisfact ory performance of the executed work for a period of twelve(12)months, from the date of successf ul completion of the work. The firm shall undertake to rectify any defect including replacement of d efective parts resulting from faulty design, poor workmanship, bad materials etc. during the execution as well as within guarantee period free of cost.
- 9. **Work Completion period**: The work completion period will be three months (90 days)from the date of placement of Supply Order
- 10.**Acceptance Criteria:** The Contractor is solely responsible for the quality of work. After successful completion of the work in all respect as per scope of work, CW section authority should furnish acceptance certificate stating that the specific job has been done satisfactory, this should accompanied with the JCC.
- 11. **Working hours**: Working hours: Working hours will be 08:00 hrs to 16:30 hrs on all working days except Sunday/Holidays. However, the working hours may be exten

ded upto 20:00 hrs. with necessary permission. If required the firm may be allowed of work even on Sunday and Holidays also after obtaining necessary permission.2. The firm has to provide all tools and tackles for the exeution of work.

- 13. The purchaser will not take any responsibility whatsoever, in the event of any accident met by contractor's men while on their duty. The contractor should submit the proper workmen compensation policy (insurance) at the time of requesting for entry properties on
- 14. The personnel deputed shall be below 60 years old, good health and physically fit to work in hot, dust noisy, and smoky environment.
- 15. Firm will submit workman insurance certificate for all the workers engaged in the job.

16. OPTIONAL SITE VISIT:

The Bidder is advised to visit and examine to obtain for itself on its own responsibility all information that may be necessary for preparing the Bid. The costs of visiting the site shall be borne by the Bidder.

The Bidder representative shall be allowed entry upon consignee premises for such visits. Only upon the express conditions that the Bidder will release and indemnity the Buyer and Consignee against all liabilities arising out of such visit including death or injury, loss or damage to property, and any other loss, damage, costs, and expense sincurred as a result of such visit.

The Bidder shall not be entitled to hold any claim against Buyer for noncompliance d ue to lack of any kind of pre-requisite information as it is the sole responsibility of the Bidder to obtain all the necessary information with regard to site, surrounding. Working condition weather etc. On its own before.

17. Safety:

Firm's offer will be inclusive of all safety equipment.MSF will not provide any safety equipment.

18. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates/documents sought in the Bid document. ATC and Corrigendum if any.
