- 6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and

- 7. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. - 12. Successful bidder will have to ensure that adequate number of dedicated technical service personals / engineers are designated / deployed for attending to the Service Request in a time bound manner and for ensuring Timely Servicing / rectification of defects during warranty period, as per Service level agreement i ndicated in the relevant clause of the bid.

- 26. IMPORTED PRODUCTS: In case of imported products, OEM or Authorized Seller of OEM should have a re gistered office in India to provide after sales service support in India. The certificate to this effect should be submitted.
- 27. IT equipment shall be IPv6 ready from day one.
- 28. Bidders shall quote only those products (Part of Service delivery) in the bid which are not obsolete in th e market and has at least 2 years residual market life i.e. the offered product shall not be declared end-of I ife by the OEM on letter head before this period.
- 29. Note- The specification's and additional clauses mentioned in "buyer added ATC" override the all other technical specifications and standard bid conditions and the material shall be supplied as per Technical Compliance submitted on OEM letterhead by L1 buyer.
